MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS MARCH 9, 1976

APPROVAL OF MINUTES:

MOTION was made by Councilman Ross, seconded by Councilman Allsup and carried unanimously that the minutes for regular meeting of February 10th and special meeting of February 24, 1976, be approved as posted.

MONTHLY REPORTS:

CITY ENGINEER - Gary Dyer reported that the construction on the water filtration plant was presently closed down and the filters are to arrive during the week of March 14, and at that time construction will continue.

CITY ATTORNEY - None.

PUBLIC HEARING - SUPPLEMENTAL BUDGET FOR FISCAL YEAR 1975-76:

Resolution No. 187 adopting Supplemental Budget was read in full. Explanation on this supplemental budget was given by City Manager.

MOTION was made by Councilman Allsup, seconded by Councilman Ross and carried unanimously that Resolution No. 187 be adopted.

LEGISLATIVE ACTION:

1. PUBLIC LIABILITY INSURANCE BIDS:

One bid was received which was from Gerald Ross Insurance Agency, which was as follows:

2. COOS FOREST PROTECTIVE ASSOCIATION AND CITY OF BROOKINGS AGREEMENT:

This is a cooperative agreement for mutual assistance between Coos Forest Protective Association and the City of Brookings for the purpose of protecting forest land and other land from fire.

3. EPA REQUEST FOR MODIFICATION OF CITY OF BROOKINGS SEWER INDUSTRIAL WASTE ORDINANCE NO. 265:

ORDINANCE NO. 268, AN ORDINANCE AMENDING ORDINANCE NO. 265 REGULATING THE USE OF PUBLIC AND PRIVATE SEWERS AND DRAINS, PRIVATE SEWAGE DISPOSAL, THE INSTALLATION AND CONNECTION OF BUILDING SEWERS, AND THE DISCHARGE OF WATER AND WASTES INTO THE PUBLIC SEWER SYSTEM, AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF was read in full by the City Attorney.

MOTION was made by Councilman Ross, seconded by Councilman Allsup that Ordinance No. 268 be read the second time by title only.

5. BROOKINGS AMBULANCE SERVICE, INC - DISPATCHING OF AMBULANCE CALLS:

Mr. Libby, who owns Brookings Ambulance Service, Inc., would like for the City Dispatchers to route the ambulance calls equally to the Brookings Ambulance Association and to his business, the Brookings Ambulance Service Inc., or inquire from the person requesting an amublance which service they would prefer. The Brookings Ambulance Association was well represented by local citizens and their opinions brought forward. Mayor Kerr advised Mr. Libby that the ambulance situation would have to be resolved between the two organizations and the City would implement whatever procedure they settle upon.

6. PAYMENT OF VOUCHERS:

MOTION was made by Councilman Ross, seconded by Councilman Allsup and carried that vouchers in the amount of \$24,912.32 for the month of February 1976 be paid.

7. REPORT BY CITY MANAGER:

Al R. Hooten discussed the Bicentennial Certification for the Brookings-Harbor area.

8. OPEN DISCUSSION:

Local water fountain maintenance. It was suggested that possibly some of the local organizations could assist in the maintenance of the water fountain.
