# MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS MAY 13, 1975

The meeting was called to order at 8:00 p.m. by Mayor Robert L. Kerr.

Members present were Councilmen William Guthrie, Jack Ross, Ellis Dowden and
Darrell Allsup.

#### APPROVAL OF MINUTES:

MOTION was made by Councilman Guthrie, seconded by Councilman Ross and carried unanimously that minutes of April 8, 1975, be approved as posted.

#### REQUEST OF CHAMBER OF COMMERCE:

Doug Peterson, on behalf of the Chamber of Commerce, requested permission to use property adjacent to City Hall for logging show during the coming Azalea Festival. Mayor and Council approved this request.

#### MONTHLY REPORTS:

City Attorney - Cameron C. Thom advised the Council he had received a letter from Kalberer Hotel Supply Co. and they advised that they were proceeding in the remodeling of the Cliff House.

Jerry Ross advised City Attorney of requested considerations before he would sign an easement for the Easy Manor Sewer Replacement project After some discussion it was suggested the City try to replace this sewer line on easements now owned by the City. Gary Dyer, City Engineer, offered to check with DEQ for their approval.

MOTION was made by Councilman Dowden, seconded by Councilman Allsup and carried that the City investigate other possibilities of going another route on this project before going to DEQ for their approval.

BROOKINGS-HARBOR INTERCEPTOR - Gary Dyer reported engineering has been completed and submitted to EPA for approval.

City Attorney was instructed to write to Harbor Sanitary District inquiring as to when the money for this project will be forthcoming to the City of Brookings.

WATER TREATMENT PLANT - MOTION was made by Councilman Ross, seconded by Councilman Guthrie and carried unanimously that the City Engineer

#### 2. COOPERATIVE AGREEMENT - COOS FOREST PROTECTIVE ASSOCIATION.

This agreement was discussed among Council, City Attorney, Fire Chief, and Richard Wessell, Fire Control Officer for U.S.F.S. Council and City Attorney objected to the large area this involves and it was suggested that maybe a better agreement could be presented in the near future.

MOTION was then made by Councilman Ross, seconded by Councilman Guthrie and carried unanimously that the agreement presented not be signed.

#### 3. PENETRYN SYSTEM - FINAL PAYMENT ON SEWER SEALING PROJECT.

City of Brookings had been holding the retainage fee in the amount of \$5,533.92 on this bill. Gary Dyer, City Engineer, and Elmer Lee, Supt. of Public Works, expressed the opinion that charges on the manholes were excessive. Penetryn System agreed to compromise and discount the amount of \$1,230.00.

MOTION was made by Councilman Guthrie, seconded by Councilman Ross and carried unanimously that the final payment of \$4,303.92 be paid to Penetryn System.

#### 4. RENEWAL OF LIQUOR APPLICATIONS.

MOTION was made by Councilman Ross, seconded by Councilman Dowden and carried unanimously that liquor applications for the following be approved:

B.P.O. Elks, Green Door, Pine Cone Tavern, Ken's Tavern, McKay's Market, Thomas & Son Distributor, O'Holleran's, Ray's Sentry, Local Market, and Cork "N" Cleaver.

## 5. REQUEST FROM FRANK S. AKIN FOR WATER SERVICE TO PROPOSED SUBDIVISION UP CHETCO RIVER.

Councilman Guthrie suggested this request be taken under advisement; that first, water has to be supplied to the Brookings area. City Engineer will soon be able to advise the capacity of the new water filtration plant and then will be able to advise if the City will be in position to sell surplus water to outside districts. #### 6. PAYMENT OF VOUCHERS - APRIL 1975.

MOTION was made by Councilman Guthrie, seconded by Councilman Ross and carried unanimously that vouchers in the amount of \$24,527.16 be paid.

- A. Barricade placed by Agnew Timber on public road. Attorney will advise.
- B. City of Brookings vs Brookings Plywood Corp. City Attorney advised this case will be at Gold Beach on June 6, 1975. Elmer Lee is to attend and be a witness.
- C. Water Fountain. City Attorney advised he had written the Trustees but has not received an answer.
- D. City Attorney was instructed to prepare an ordinance pertaining to City Manager - City Council type of governments. This ordinance to be put to a vote of the people.
- E. Councilman Ross advised the swimming pool had been vandalized on May 12th and extensive damage done. Chief of Police was instructed to enforce the curfew law. Possibly this might stop some of the vandalism going on in the City.

#### ADJOURNMENT:

MOTION was made by Councilman Guthrie, seconded by Councilman Ross and carried unanimously the meeting be adjourned. The meeting then adjourned at 9:45 p.m.
