WATER STORAGE RESERVOIR - This project is almost completed and ready for connection.

WATER TREATMENT PLANT - Design lacks electrical part for completion.

WHARF STREET STORM DRAIN PROJECT - Is progressing satisfactorily.

EASY MANOR SEWER REPLACEMENT - This project is being redesigned along guidelines requested by Mayor & Council. This sewer line will be placed alongside the existing line and easements. Bid opening on this project is scheduled for July 8, 1975 at 3:00 p.m.

BROOKINGS-HARBOR INTERCEPTOR - WATER TREATMENT PLANT & MEMORY LANE PUMP STATION - Bids on these projects are scheduled for August 12, 1975.

6. SEPTIC SERVICE TRUCK DUMP & FEES.

V. L. Strutton, Chief Operator of Waste Water Treatment Plant, requested from Council fee schedule and restrictions on septic service companies dumping in city sewer.

MOTION was made by Councilman Guthrie, seconded by Councilman Ross and carried unanimously that septic service companies pay one cent per gallon payable prior to dumping, operator be given the right to accept or reject any load prior to injection into system and fines or rejection of privileges be initiated for any violation.

It was suggested that these companies pay at Recorder's Office before each dump as it could be handled by signing trip permits and pay accordingly.

7. ORDINANCE NO. 258 - AN ORDINANCE CALLING FOR A SPECIAL MUNICIPAL ELECTION

in the City of Brookings, Curry County, Oregon, to submit to the legal voters of said City a measure providing for the establishment of the Office of City Manager providing for the powers and duties of such office, calling and making provision for official election and declaring and emergency, was read in full.
