## SPECIAL COUNCIL MEETING BROOKINGS COMMON COUNCIL CITY OF BROOKINGS DECEMBER 23, 1975

Meeting was called to order at 7:05 p.m. by Mayor Robert L. Kerr. Members present were Councilmen William Guthrie, Jack Ross, Ellis Dowden, and Darrell Allsup.

All members of the Council of the City of Brookings consented to this special meeting and a signed statement is made a part of these minutes.

This special meeting was called for the purpose of decision on the proposed litigation with Brookings Utility Co., et al.

The law offices of Souther, Spaulding, Kinsey, Williamson, & Schwabe of Portland, Oregon, by letter, advised of the investigation they had made on the sale of the Brookings Utility Co. property to the City of Brookings. Prior to the execution of the agreement certain representations were made by representatives of the company that "100 acres, more or less" would be conveyed, including the watershed surrounding the reservoir. Some time after the property was conveyed it was discovered that only about 40 acres had actually been conveyed. Also, a water line shown on maps furnished by the company as being 12 inch lines were in fact only 8 inch lines.

After some discussion, MOTION was made by Councilman Dowden, seconded by Councilman Guthrie and carried unanimously that the law office of Souther, Spaulding, Kinsey, Williamson, & Schwabe be authorized to proceed with the case against Brookings Utility Co., et al, and Edward W. Riley, Engineer for Brookings Utility Co., and report to the Council when \$1,000.00 has been incurred on each case in order that Council can be advised of progress. Then Council will advise if they are to continue with the case.

## ADJOURNMENT:

MOTION was made by Councilman Allsup, seconded by Councilman Guthrie that the meeting be adjourned. The meeting then adjourned at 7:45 p.m.
