MINUTES SPECIAL COUNCIL MEETING BROOKINGS COMMON COUNCIL CITY OF BROOKINGS JULY 20, 1974

This special meeting, which was convened for the purpose of hiring an engineer, was called to order at 10:50 a.m. by Mayor pro tem Rush Long in the Council Chambers of the City Hall. Council members present were Robert G. Earle and William J. Guthrie. Mayor Wilma M. Kemp and Councilman Jack Ross were absent.

A letter dated July 18, 1974, from H.G.E., Inc. re bid proposals on water filtration plant equipment, and their recap of bid evaluation, their project #165-3-73, was discussed and copies are made a part of these minutes.

Councilman Robert G. Earle MOVED that the Neptune Microfloc proposal (A) Basic Bid - Schedule A for \$143,968.00 be accepted by the Council. Councilman Guthrie seconded and the Motion carried unanimously.

Mayor pro tem informed Council he had talked with Harry Parsi over phone recently and learned Parsi had received a raise from his employer and was now asking for \$14,000 a year.

Councilman Earle mentioned the changing of identity from engineer to Director of Public Works for the City of Brookings. As a Director he is required to have engineering qualifications but is not required to become a certified engineer with the State of Oregon. This change in title had been discussed and agreed upon previously.

MOTION by Councilman Earle that we hire Harry Parsi at the recommended and accepted rate of \$14,000 a year under the conditions that he fulfill no more than the six month probationary period and he serve at the pleasure of the Council on this probationary status up to this period of time until we see fit to offer him a full and binding contract in writing. Motion seconded by Councilman Guthrie and carried unanimously.

Councilman Earle made MOTION in relation to the previous Motion which was approved by the Council in the hiring of Harry Parsi, that we pay him, during his probationary period, the monthly equivalent of the annual rate of \$14,000 a year which I believe is \$1,167 per month with consideration being given at the end of this probationary period for establishing a floor salary under his contract. Motion seconded by Councilman Guthrie and carried unanimously.

MOTION by Councilman Guthrie, second by Councilman Earle that meeting be adjourned. The meeting then adjourned at 11:10 a.m.
