Representative, City Representatives, and H.G.E., Inc. Tentative date is October 21st at 8:00 p.m.

EMERGENCY MEETING

CITY OF BROOKINGS OCTOBER 10, 1974

The purpose of this meeting was for approval of paying property taxes and police car bids.

PROPERTY TAXES:

When the contract to buy the Brookings Utility Co. was finalized the City of Brookings was responsible for additional property taxes. As of this date they had not been paid and judgment had been filed against Brookings Utility Co. for collection.

MOTION was made by Councilman Earle, seconded by Councilman Guthrie and carried unanimously that property taxes in the amount of \$6,161.63 be paid.

POLICE CAR BIDS:

Akin Motor Co. delivered a letter in person dated October 9, 1974, clarifying their sealed bid of October 8, 1974, on police car. A portion of said letter reads as follows:

"In reference to our letter dated September 30, 1974, responding to your request for bid on One 1975 Ford, four door sedan, we were not aware that the bid should include the sale price of the vehicle.

The sale price is \$4,984.05 and does not change the net difference in the bid of \$3,734.00 leaving a trade-in value of the present car of \$1,250.05. If this information satisfies the needs of the council we request that the bid be awarded at the special meeting October 10, 1974."

MOTION was made by Councilman Earle, seconded by Councilman Guthrie and carried unanimously that the Motion made by Councilman Earle on October 8, 1974, to readvertize for police car bids be rescinded.

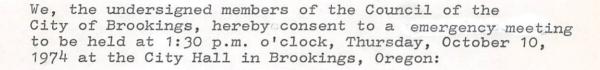
