City Engineer - Gary Dyer reported that their crew has been working the last three weeks on information needed for the water treatment plant. It is undecided as yet where the plant will be located. The sanitary sewer and storm drain projects are progressing satisfactorily.

MOTION was made by Councilman Long, seconded by Councilman Ross and carried unanimously that the Audit Report prepared by Rae & Haydal for the fiscal year 1972-1973 be accepted.

3. PETITIONS FOR CONSOLIDATION OF BROOKINGS, HARBOR, AND NORTH BROOKINGS.

Cameron C. Thom, City Attorney, informed the Council that the number of signatures appear to satisfy the Oregon Statutes for the required 10% of registered voters in the areas involved. However, the petitions as submitted are invalid for each individual sheet is to be certified by the person circulating the petition. Some of the certifications were invalid due to the fact that two people signed one certification. Mr. Thom recommended to the Council that they reject these petitions as submitted and petitions be returned to Mr. Floyd Somers.

MOTION was made by Councilman Ross, seconded by Councilman Long and carried unanimously that these petitions be rejected as presented.

Mr. Thom then informed the Council and audience that if these petitions were resubmitted 60 days from now and met all the requirements, they could be brought to the vote of the people in the General Election in November 1974. If this consolidation was approved at the November 1974 election then a tax base could be established, otherwise it would be two more years beofre a tax base could be established.

4. APPRAISAL OF ELKS PROPERTY.

Property of B.P.O. Elks No. 1934, adjacent to City Hall property, is up for sale. This irregular shaped parcel of land is less than one-half acre. The Elks are asking the amount of \$19,500.00. An appraisal was prepared by C. Edward Dempsey, Realtor, for the amount of \$12,200.00.

Councilman Guthrie inquired as to the reason the City would be interested in this property. Councilman Guthrie was informed it was for the reason of expansion of the City Hall in the future, and if the property is not purchased now it would be sold to some other interested party.

Mayor Kemp requested that Councilmen Long, Ross, and Guthrie, meet with representatives of the Elks Club and inquire as to what price they would accept.

ORDINANCE NO. 251 - AN ORDINANCE PROVIDING FOR THE ISSUANCE OF PROMISSORY NOTES OF THE CITY OF BROOKINGS, OREGON, IN THE AGGREGATE PRINCIPAL SUM OF NINE HUNDRED EIGHTY-THREE THOUSAND DOLLARS (\$983,000.00) FOR THE PURPOSE OF PROVIDING INTERIM FINANCING FOR THE COSTS OF ACQUISITION, CONSTRUCTION AND REPAIR OF A WATER WORKS AND WATER WORKS SYSTEM WITHIN AND WITHOUT THE BOUNDARIES OF THE CITY OF BROOKINGS, OREGON, AND AUTHORIZING AND DIRECTING THE CITY RECORDER TO ADVERTISE FOR WRITTEN BIDS ON SAID NOTES, AND DECLARING AN EMERGENCY.

RE: VanDuzee Sub-Division

Gentlemen:

Recently Mr. Charles Williams contacted me regarding the street in the VanDuzee Sub-Division known as Paradise Lane.

The street is presently planned for 38 feet width plus the burbing. This leaves very little distance to the property line for such things as water meters, a parkway strip where trees or shrubs could be planted and possibly later on a sidewalk might be added.

I am therefore requesting that you consider the reduction in width of this street to 32 feet from 38 feet for the above and the following reasons.

- 1. Paradise Lane is approximately 600 feet long and ends in a cul-de-sac. Therefore we believe 38 feet is wider than necessary for such a short street little more than a block long.
 - 2. Ransom XXXXXXXX Creek is just beyond the cul-de-sac and it appears financially impractical for this street to be continued and to have a long bridge at that point which is quite a wide canyon.
 - 3. 32 feet allows for a car to be parked on both sides of the street and still give sufficient room for 2 way traffic.
 - 4. The property owners are all in favor of this including myself.
 - 5. A wide street encourages faster speeds and drag racing. None of us residents want this .
 - 6. We want this Sub-Division to be a nice residential area, a place we can be proud of.
 - 7. 32 feet still makes it a wide street, exceeding most of the thru streets in Brookings and ceptainly adequate for 13 single family dwellings plus 3 apartment residences.

I have discussed this with the present property owners who are either living in this sub-division for or have homes under construction. I hope you will give this consideration so we can proceed with the paving and curbs.
