# MINUTES BROOKINGS COMMON COUNCIL June 13, 1972

The meeting was called to order at 8:00 p.m. by Mayor Les Williams. Members present were Councilwoman Wilma Kemp and Councilmen Rush Long, William Higham and Cal Gorte.

### APPROVAL OF MINUTES:

MOTION was made by Councilman Gorte, seconded by Councilman Higham and carried unanimously that the minutes of regular meeting of May 9, 1972, and special meeting of May 30, 1972, be approved as posted.

### PUBLIC HEARING:

### 1. BUDGET FOR 1972-1973.

This public hearing was called for the purpose of discussion of 1972-1973 City of Brookings Budget. All persons that so desired were heard. The Council agreed to go to the vote of the people to exceed the 6% limitation.

Resolution No. 164, Special Municipal Election to Exceed the 6% Limitation in the Amount of \$28,262.00, was read in full.

MOTION was made by Councilman Higham and seconded by Councilman Gorte that Resolution No. 164 be adopted. Roll call was as follows:

The Resolution was then declared adopted.

### MONTHLY REPORTS:

City Attorney - None.

City Engineer - Mr. Erichsen reported that he had contacted D.E.Q. in regard to the addition of the sewerage plant, and that they had approved the plans prepared by H.G.E., Inc. Mr. Erichsen recommended that the Council award the bid to the low bidder John Kovtynovich.

MOTION was made by Councilman Higham, seconded by Councilwoman Kemp and carried unanimously that the bid be awarded to John Kovtynovich for the amount of \$436,066.00, on the stipulation that the Council have authorization to approve the subcontractors.

### LEGISLATIVE ACTION:

1. ORDINANCE NO. 231 - AMENDMENT TO ORDINANCE NO. 116
PROVIDING FOR A REVISED MONTHLY CHARGE FOR THE USE
OF THE SANITARY SEWER SYSTEM BY MULTIPLE FAMILY
DWELLINGS.

Ordinance No. 231 was read in full for the second time.

MOTION was made by Councilman Long, seconded by Councilman Gorte and carried unanimously that Ordinance No. 231 be adopted.

2. AWARDING OF SAFE DRIVING PINS AND CARDS TO CITY EMPLOYEES.

Mayor Williams presented pins and cards to Elmer S. Lee, Charles W. Williamson, Samuel Williams and Phil Bischof. These were for driving one year without a chargeable accident.

3. SALE OF CITY OWNED PROPERTY.

MOTION was made by Councilman Gorte, seconded by Councilman Higham and carried unanimously that property located at the corner of 3rd and Ransom be sold to Mike Faulkner and Ramon Faulkner for the cash amount of \$2,000.00 plus costs. This property is tax lot 2500, map 41-13-6BA.

4. OREGON STATE HIGHWAY DIVISION - UTILITY CONDUIT EXTENSION BEYOND BRIDGE IMPACT PANELS.

## 5. PROPOSED SANITARY SEWER SYSTEM IN THE BEACHVIEW SUBDIVISION.

MOTION was made by Councilman Gorte, seconded by Councilman Higham and carried unanimously that the proposed sanitary sewer system in the Beachview subdivision be accepted upon recommendation of Elmer S. Lee, Superintendent of Public Works and Roy Erichsen, City Engineer.

### 6. PAYMENT OF VOUCHERS - MAY 1972.

MOTION was made by Councilman Higham, seconded by Councilman Long and carried that vouchers in the amount of \$11,405.67 be paid.

### OTHER MATTERS:

1. MONDAY, JULY 3, 1972, PAID HOLIDAY FOR CITY EMPLOYEES.

MOTION was made by Councilman Higham, seconded by Councilman Gorte and carried unanimously that the City Employees be granted Monday, July 3, 1972, off as a paid holiday.

2. DAWSON TRACT FIRE CONTRACT.

MOTION was made by Councilman Higham, seconded by Councilman Gorte and carried unanimously that the fire contract between City of Brookings and Dawson Tract be renewed. This contract to expire June 30, 1973.

3. <u>PLANNING COMMISSION RECOMMENDATION - RE HORSES WITHIN CITY LIMITS.</u>

The City Planning Commission recommended to the City Council at present, or until the Council presents a proposed ordinance change, that Ordinance No. 216 be left as is. Ordinance No. 216, as is, does not permit livestock within the city limits.

Discussion followed.

Mayor Williams, with approval of Council, named a
