# MINUTES BROOKINGS COMMON COUNCIL CITY OF BROOKINGS OCTOBER 10, 1972

The meeting was called to order at 8:00 p.m. by Mayor Les Williams. Members present were: Councilwoman Wilma Kemp and Councilmen Cal Gorte and William Higham. Absent was Councilman Rush Long.

#### APPROVAL OF MINUTES:

Councilwoman Kemp ask for a correction of the September 12, 1972, minutes on the extension of Fifth Street to connect to Oregon Coast Highway 101. The Motion that was made by Councilwoman Kemp was that this request be tabled and not to be held over until the regular council meeting of October 10, 1972.

MOTION was made by Councilman Higham, seconded by Councilman Gorte and carried that the minutes of September 12, 1972, be approved as corrected.

#### PUBLIC HEARINGS:

None.

#### MONTHLY REPORTS:

City Attorney - None.

City Engineer - Mr. Gary Dyer informed the Council that the Sewer Plant Addition is proceeding satisfactorily. The sewer sealing project will begin on October 23, 1972.

Superintendent of Public Works - Mr. Elmer Lee reported that the City crew had installed some 450 feet of permanent storm drain pipe and had corrected several sewer problems.

### LEGISLATIVE ACTION:

#### 1. POLICE CAR BIDS.

Only one bid was received and that was from Akin Motor Co. which was sale price without trade-in of present police car of \$4,207.00 and with trade-in the net price of \$2,607.00.

MOTION was made by Councilman Gorte, seconded by Councilman Higham and carried that the bid of Akin Motor Co. with trade-in of present police car with the net price of \$2,607.00 be accepted.

2. REQUEST FROM ROY BRIMM TO OBTAIN CITY FRANCHISE FOR TREE TOPPING BUSINESS IN THE CITY OF BROOKINGS.

Cameron C. Thom, City Attorney, informed the Council that it is not general practice to issue franchise for businesses, and suggested that Mr. Brimm obtain a city license to do his tree topping business within the City.

MOTION was made by Councilman Gorte, seconded by Councilman Higham and carried that Mr. Brimm's application for franchise be rejected.

3. REQUEST FROM BROOKINGS FIRE DEPARTMENT FOR EXTENSION OF FIFTH STREET TO CONNECT TO OREGON COAST HIGHWAY 101.

Mr. Bankus, who owns the above named property, was in the audience and he informed the Council that the City could purchase this property but that they would have to pay a fair price. The City Engineer was instructed to prepare a diagram of this property and it will be presented to Mr. Bankus to obtain his price.

4. LEAGUE OF OREGON CITIES CONVENTION - November 12-14, 1972.

Members of Council are to inform the City Recorder who is going to attend this convention so reservations can be made.

5. PAYMENT OF VOUCHERS.

MOTION was made by Councilman Gorte, seconded by Councilman Higham and carried that vouchers in the amount of \$8,086.61 for the month of September 1972 be paid.

#### OTHER MATTERS.

TELEPHONE FRANCHISE. Mayor Williams informed the Council that the present franchise expires in December of this year.

MOTION was made by Councilwoman Kemp, seconded by Councilman Gorte and carried that the City Attorney be instructed to notify General Telephone Co. that the Council desires that the new franchise be for a ten year period with 3% charge for the franchise.

CONSOLIDATION OF HARBOR & BROOKINGS. Mayor Williams suggested that the City of Brookings start the ball rolling towards consolidation of Harbor into Brookings.

Much discussion followed.

Councilwoman Kemp felt that Harbor should approach the City for annexation and then the City of Brookings go on from there. It was suggested that if Harbor was annexed with Brookings then they could be included in the sewer district. No action was taken towards the annexation of Harbor and Brookings.

Elmer S. Lee asked for permission to attend a hearing in Portland on October 25. Permission was granted.

Mayor Williams declared the meeting adjourned at 9:25 p.m.
