# MINUTES CONTINUED MEETING OF BROOKINGS COMMON COUNCIL JANUARY 19, 1971

The continued meeting of the Common Council was held in the Council Chambers of the City Hall on the above date. The meeting was called to order at 8:00 p.m. by Mayor Lester R. Williams. Members present were Councilwoman Wilma Kemp and Councilmen Bill Higham and Rush Long.

# LEGISLATIVE ACTION

- 1. MATOT-OXFORD-CEDAR STREET SANITARY SEWER

  No action was taken on awarding the bid. This project is being held in abeyance.
- 2. GRADING PROJECT OF CYPRESS, MAPLE, PORTION OF CEDAR & OXFORD

This project is being held in abeyance for the probability of readvertising.

- 3. COOS-CURRY COUNCIL OF GOVERNMENTS

  The two selected representatives for the City of Brookings are Mayor L. R. Williams and Council-woman Wilma Kemp.
- 4. APPOINTMENT OF PLANNING COMMISSION MEMBER

  MOTION was made by Councilman Higham, seconded by Councilman Long, and carried unanimously that Gladys Kanick be appointed as a member of the Planning Commission to replace the vacated term of Rush Long. This term expires April 21, 1973.
- 5. OREGON STATE HIGHWAY DIVISION

Each year the State Highway Division administers a \$250,000 fund which is allocated in the amount of \$25,000 each to qualifying cities under 5,000 population for the construction of street or streets, not a part of the state highway system, which are receiving excessive wear through increases in population in the area or heavy and unusual traffic.

MOTION was made by Councilwoman Kemp, seconded by Councilman Long and carried unanimously that the City Recorder write to State Highway Division requesting an application for the above described allocation.

#### PUBLIC HEARINGS

1. GENERAL - Mr. Dan Lewis requested that a <u>yield the</u>
right-of-way sign be installed on Azalea Park Road
by Pacific Avenue. The City had installed a stop
sign but it proved to be unsatisfactory and was
removed. Mr. Elmer Lee, Superintendent of Public
Works, will discuss this problem with Mr. Bud Cross,
Chief of Police, for the feasibility of this request.

Tanbark Sewer Interceptor & Sewer Lift Station.

It was reported that there were 75.9% remonstrances against this Assessment District. As for now this project has been defeated.

## OTHER MATTERS

Mrs. Mary J. Brimm remarked that it was so nice to see so many people in the audience, and if more people would attend the meetings and all work together we could have a much nicer city.
