# MINUTES BROOKINGS COMMON COUNCIL MARCH 9, 1971

The regular meeting of the Common Council was held in the Council Chambers of the City Hall on the above date. The meeting was called to order at 8:00 P.M. by Mayor Lester R. Williams. Members present were: Councilwoman Kemp and Councilmen Bill Higham and Rush Long.

#### APPROVAL OF MINUTES

It was moved by Councilman Higham, seconded by Councilman Long and carried that the minutes of February 9, 1971 be approved.

#### PUBLIC HEARING

1. GENERAL - E. G. Samuel, Chiropractic Physician, a representative of the local organization called the "Bridge", spoke on their behalf. Mr. Samuel asked that the Council back this organization.

Andy Billings stated that the Bridge had received a lot of criticism and he is interested in helping them get on their feet and prove that they can be a credit to the community. The Bridge is considering the possibility of having a clean up litter day.

MOTION was made by Councilman Higham, seconded by Councilman Long that the Bridge be given authorization to have a clean up litter day in the City of Brookings on March 14, 1971. Motion carried unanimously.

E. G. Samuel invited the public to open house to be held on St. Patricks at the Bridge.

#### LEGISLATIVE ACTION

1. MAYOR'S APPOINTMENTS.

Mayor Williams appointed Dellis Oliver as a member of the Parks and Recreation Committee.

MOTION was made by Councilman Higham, seconded by Councilman Long and carried unanimously that Dellis Oliver be appointed as a member of the Parks and Recreation Committee.

Mayor Williams appointed Councilman Long as Commissioner of the Parks and Recreation Committee.

Mayor Williams appointed William Guthrie and Chet Thompson as members of the Planning Commission.

MOTION was made by Councilwoman Kemp, seconded by Councilman Long and carried unanimously that William Guthrie and Chet Thompson be appointed as members of the Planning Commission for the term ending April 1, 1975.

MOTION was made by Councilman Higham, seconded by Councilman Long and carried that Jack Holte be reappointed to the Planning Commission for the term ending April 1, 1975.

2. \$485,000 GENERAL OBLIGATION SEWER BONDS, SERIES OF 1970.

Three bids were received which were as follows:

U. S. National Bank of Oregon with net interest cost to the city of \$313,089.05

Mr. Fred M. Gagnon, Vice President and Cashier, Western Bank, Coos Bay, Oregon, questioned the legality of the low bid of First National Bank that was submitted with the cashier's check as good faith deposit, rather than certified check that was specified in the advertised Notice of Sale. These bids were held in abeyance.
