MINUTES BROOKINGS COMMON COUNCIL MAY 12, 1970

A regular meeting of the Common Council was held in the Council Chambers of the City Hall on the above date. The meeting was called to order at 8:00 P.M. by Mayor Harold R. Young. Members present were: Councilmen Bill Higham, Scott Sheppard, Gil Batty and Alden Loring.

APPROVAL OF MINUTES

It was moved by Councilman Sheppard, seconded by Councilman Higham, and carried to approve the minutes of the regular meeting of April 14, 1970.

PUBLIC HEARINGS

1. GENERAL - Mrs. Mary J. Brimm inquired as to the disposition of the \$50,000 that was to have been received from the County for payment on water pipe that the City of Brookings had purchased. Mrs. Brimm was informed that there has been no further progress.

Mrs. Alice Rausch expressed her views on the condition of the paving on Easy Street which has been partially reconditioned by Brookings Water Co. Mrs. Rausch was informed that the consensus was that as soon as Brookings Water Co. is able to purchase hot mix that the street will be restored to the original condition.

LEGISLATIVE ACTION

2. COMPREHENSIVE PLAN FOR THE CITY OF BROOKINGS.

Recommendation of Planning Commission No. 142.

The City Planning Commission recommended to the City Council to adopt the Comprehensive Plan for the City of Brookings as prepared by the Bureau of Municipal Research at the University of Oregon, titled "Planning for Brookings".

Mr. Al Henderson, City Administrator, explained that this "Planning for Brookings" plan is a policy guide and plan for the City, it does not change the zoning nor does it effect the sub-division regulations. The zoning and sub-division regulations will be entertained at a later date.

MOTION was made by Councilman Batty and seconded by Councilman Loring that Resolution No. 147, "Planning for Brookings" as the Comprehensive Plan for the City of Brookings be adopted. Motion carried unanimously.

- BROOKINGS-WINCHUCK RIVER SECTION THROUGHWAY AGREEMENT OREGON STATE HIGHWAY DIVISION. Letter from State Highway Division requesting agreement with City of Brookings was read. After some discussion it was recommended by the City Attorney that this agreement be tabled until the next regular council meeting June 9, 1970. Agreement was then tabled by City Council.
- 4. RECOMMENDATION TO PERMIT INSTALLATION OF SIGN ON CITY PROPERTY. Recommendation of Planning Commission No. 141.

The Planning Commission recommended to the City Council to grant Vollstedt Volkswagen a permit to install a sign on City property at the Southeast Corner of Wharf Street and Chetco Avenue.

MOTION was made by Councilman Batty and seconded by Councilman Loring that Planning Commission Recommendation No. 141 be denied. Motion carried unanimously.

FOR AZALEA FESTIVAL - CHAMBER OF COMMERCE. The Chamber of Commerce requested permission to erect and maintain a banner, 30 feet in length and 4 feet wide, and painted thereon "Welcome-Azalea Festival, May 29, 30, and 31" over and across the right-of-way of Oregon Coast Highway, at Milepost 356.3. The banner to be removed by June 5, 1970.

MOTION was made by Councilman Sheppard and seconded by Councilman Higham that the above named request be granted. Motion carried unanimously.

MAY 30 - Azalea Festival Parade Committee requested permission to conduct a parade on May 30, 1970; the parade route to be from Arnold Lane on Chetco Ave., south to Oak St., east on Oak St. to Pacific Ave., south on Pacific Ave. to Azalea Park Road, south on Azalea Park Road to Azalea State Park; between the hours of 10:00 A.M. and 1:00 P.M., with traffic detoured between 8:00 A.M. and 1:30 P.M. South bound traffic will be detoured west on Arnold Lane to Fifield St., south on Fifield St. and across Brookings Plywood Corporation property to Railroad St., on south on Railroad St. to Alder St., east on Alder St. to Chetco Ave; north bound traffic just the reverse.

MOTION was made by Councilman Loring and seconded by Councilman Higham that the above named request be granted. Motion carried unanimously.

7. PAYMENT OF VOUCHERS - APRIL 1970.

MOTION was made by Councilman Sheppard and seconded by Councilman Batty that vouchers in the amount of \$10,764.51 be paid. Motion carried unanimously.

OTHER MATTERS

Resolution No. 148 authorizing filing of application with the United States of America for an advance to provide for the planning of public works under the terms of Public Law 560, 83rd Congress of the United States, as amended was read and discussed.

MOTION was made by Councilman Sheppard and seconded by Councilman Batty that Resolution No. 148 be adopted. Motion carried unanimously.

Mayor Harold R. Young expressed his approval and views in regard to the new tax base measure that will be voted on in the election to be held May 26, 1970. Mayor Young is in hopes that each and every citizen will vote "yes" on this ballot. Councilman Batty and Councilman Sheppard supported the Mayor on the proposed tax base issue. Mayor Young also stressed the importance of voting "yes" on the charter amendment to change the form of government to a Council-Manager Plan. The Council agreed with the position as outlined by the Mayor.

ADJOURNMENT

MOTION was made by Councilman Batty and seconded by Councilman Sheppard and carried that the meeting be adjourned. The meeting then adjourned at 9:10 P.M.
