MINUTES BROOKINGS COMMON COUNCIL November 12. 1969

A regular meeting of the Common Council was held in the Council Chambers of the City Hall on the above date. The meeting was called to order at 8:05 p.m. by Mayor Harold R. Young. Members present were: Councilmen Bill Higham, Scott Sheppard, Alden Loring and Gil Batty.

APPROVAL OF MINUTES

Minutes of regular meeting of October 14, 1969 were approved as read.

PUBLIC_HEARING

- REQUEST CONCERNING CLARIFICATION OF MATOT STREET LOCATION. Request of Ralph Cheney, for the clarification of Matot Street location was discussed at length. Mr. Cheney maintains that approximately 9 feet of his property on the corner of Matot and Railroad Streets is now a public street. Mr. Cheney agreed to give 10 feet of his property for street purposes if the owners on the opposite side of the street would also relinquish 10 feet. Mayor and Council were in agreement that the property owners on the East side of Railroad Street should be contacted for the possibility of the donation of 10 feet for street.

3. INSTALLATION OF SEWER MAIN LINE - THIRD AVE. Elmer S. Lee, Superintendent of Public Works, reported that Victor B. Brown, owner of Tax Lot 2600-41-13-6BA, requested the extension of the sewer main line from Easy Street up Third Avenue to the upper end of his property, approximately 600 feet.

MOTION was made by Scott Sheppard and seconded by Bill Higham that the City Engineer be authorized to prepare plans and specifications for the purpose of an Assessment District from Easy Street up Third Ave. Motion carried unanimously.

4. REQUEST FOR IMPROVEMENT OF CEDAR STREET. Signed petition for a street improvement project for the purpose of constructing paving, curbs and drainage on Cedar Street from Memory Lane to Maple Street, Brookings, Oregon, was presented by property owners Blaine Herkelrath and James Barnes. Lots 6, 7, 8 and 9 in the Seaview Subdivision.

Sheppard the City Engineer be authorized to prepare plans and specifications for the proposed improvement district. Motion carried unanimously.

5. AGREEMENT WITH OREGON STATE HIGHWAY DEPARTMENT - SEWER CONNECTION HARRIS BEACH STATE PARK. Agreement with Oregon State Highway Department and City of Brookings was read and discussed.

MOTION was made by Scott Sheppard and seconded by Gil Batty that this Agreement be tabled until the meeting of November 25th for further discussion. Motion carried unanimously.

6. FEDERAL GRANT OF \$9,180.00 TO CITY OF BROOKINGS FOR WASTE TREATMENT WORKS. Letter announcing Grant to the City of Brookings was read.

MOTION was made by Scott Sheppard and seconded by Alden Loring that the City of Brookings accept the Grant of \$9,180.00 from the Federal Water Pollution Control Administration. Motion carried unanimously.

7. REQUEST DAY AFTER THANKSGIVING AS HOLIDAY FOR CITY EMPLOYEES.

MOTION was made by Gil Batty and seconded by Bill Higham that Friday, November 28 be a holiday for city employees. Motion carried unanimously.
