REGULAR MEETING OF THE COUNCIL CITY OF BROOKINGS OCTOBER 8. 1968

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present were Henry Kerr, Lloyd Mosier, Gilbert Batty and Alden Loring.

Reporters present were Marge Barrett, Joel Buffington and Dick Keusink.

A letter from Cooperative Extension Service advising that the Curry County Planning Commission has been designated as the Economic Development Administration (EDA) Advisory Board for the County. They stated that Curry County has been declared an area substantial unemployment by the EDA and as a result of this Curry County is eligible for public works grants on projects that will improve employment opportunities. The EDA would provide 50% of the project and the local people would provide 50%. No action was taken on this application because no employment opportunities are foreseen in the near future.

A letter from Edward W. Riley, Professional Engineer from North Bend, Oregon was read. He would like to meet with the Council and express his experience and qualifications for a study of the present sewer system and treatment plant. Council recommended that he meet with them at the November 12th Council meeting.

Bids were submitted for the new 1969 Police car. Bid from Akin Motor Co.; sale price without trade-in of present police car \$2,882.34 and with trade-in \$1,532.34. Bid from Richard Chevrolet; without trade-in \$2,721.50 and with trade-in \$1,121.00. Bid from Chetco Motor Co.; without trade-in \$2,798.00 and with trade-in \$1,600.00. MOTION was made by Lloyd Mosier that the low bid of Richard Chevrolet of \$1,121.00 with trade-in be accepted. Motion seconded by Alden Loring and was passed unanimously.

Engineering Department was instructed to contact once again the owners that have property abutting the Fern Avenue paving project with a lower price per foot. Also to contact the County and inquire if they would help participate in this paving project.

Attending the League of Oregon Cities in Portland, Nov. 17-19 are Alden Loring, Gil Batty, Henry Kerr, Lloyd Mosier, Bruce J. Manley, C. M. Cross and Elmer Lee.

Request of Assembly of God Church to put up a sign was tabled until the November meeting. Building Inspector was instructed to contact them and advise.

Building Inspector Lee Fountain brought to the attention of the Council that an amendment should be added to the adopted Uniform Sign Code. This amendment would be part of Ordinance No. 169 which was repealed on June 11, 1968. City Attorney will have this amendment prepared by Nov. 12th Council meeting.

Lee Fountain, a member of the Curry County Planning Commission ask for permission for the County Planning Commission and the people of Dawson Tract to meet in the City Hall in the near future. Council granted them permission.

Request from Brookings Water Co. was presented for a pavement cut permit to extend water line on Park Ave. The permit was granted subject to Ordinance No. 200.

Erichens sewer plan request was tabled until the Nov. 12th Council meeting.

A minimum bid price of \$13,570.18 was set for the old fire hall and jail property. As soon as the title is approved by the Title Co. this property is to be advertised for sale.

Vouchers totaling the amount of \$7,186.91 were presented for payment. MOTION by Henry Kerr that the vouchers be paid, motion seconded by Gil Batty. Motion was passed unanimously.

Meeting was declared adjourned at 9:20 P. M.

Personel session was held after the Council. The Mayor and Council hired Marjorie B. McKernan to replace the City Recorder's position which was vacated by Robert O. Dimmick, Jr. on September 30, 1968.
