## REGULAR MEETING OF THE COUNCIL CITY OF BROOKINGS DECEMBER 10, 1968

The meeting was called to order at 8:05 P.M. by Mayor Bruce J. Manley.

Minutes of the November 12th Council meeting were approved as posted.

Mr. Ralph Cheney appeared before the Council, who owns property on Matot and Railroad Streets. He stated that some of the roadway pavement is on his property. He wishes that it be a matter of record that on the corner of his property on Railroad and Matot Streets that 8 feet of the pavement and on the other end of his property that 3 feet of the pavement is on his property. This request was tabled until the January 14th meeting so that the City can make a survey of this property.

MOTION was made by Gil Batty that the City Recorder advertise for gasoline bids to be opened at 8:00 P.M., January 14, 1969. MOTION was seconded by Henry Kerr. MOTION carried.

Vouchers totaling \$6,107.32 were submitted for payment. MOTION was made by Alden Loring that the vouchers be paid. MOTION was seconded by Lloyd Mosier. MOTION carried.

Mrs. Roy Brimm was in attendance and asked the Council what had been done towards getting good clean water for the City since the last Council meeting. The Council stated that as far as they know nothing has been done, and that no word has been received in regards to the arbitration agreement between the City and the Brookings Water Company.

C.M. (Bud) Cross, Chief of Police expressed his appreciation of the cooperation his department had received from the outgoing Mayor and Council.

MOTION was made by Lloyd Mosier that the meeting be adjourned. MOTION was seconded by Alden Loring and was carried. The meeting was adjourned at 9:05 P.M.
