

REGULAR MEETING OF THE COUNCIL  
CITY OF BROOKINGS  
FEBRUARY 13, 1968

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present were Lloyd Mosier, Gilbert Batty, Alden Loring, and Henry Kerr.

Dick Keusink was the reporter present.

Minutes of the January 9 meeting were read and approved. It was pointed out that Ordinance 2, Section 6, requires that the minutes of all meetings be read at each of the following regular meetings.

Planning Commission Recommendation No. 127, pertaining to house trailers and mobile homes within the city limits, was read. Lloyd Mosier made a MOTION that Planning Commission Recommendation No. 127 be accepted. Henry Kerr seconded the motion which was unanimously carried.

A letter from the Brookings-Harbor Chamber of Commerce was read and attached hereto. No action was necessary on this letter.

Resolution No. 130, an application for state street aid, was read to the Council. Henry Kerr made a MOTION that Resolution No. 130 be accepted. Following a second by Lloyd Mosier, the motion was passed unanimously.

A letter from the Municipal Judges Association soliciting opinions from various cities pertaining to furnishing defendants with free attorneys and free jury trials was read. The Council indicated they were opposed to this to this particular item, but since it is now law, they must find some way for providing for it in future budgets. They also pointed out that no money had been included in the current budget for this item.

Bids for diesel and stove oil were opened and read. Atlantic Richfield bid \$.1325 for diesel oil and \$.132 for stove oil. Union Oil Co. bid \$.134 for diesel oil and \$.138 for stove oil. Shell Oil Co. bid \$.1393 for diesel oil and \$.158 for stove oil. Henry Kerr made a MOTION that the low bid submitted by Atlantic Richfield be accepted. Alden Loring seconded the motion. Manley, Kerr, and Loring voted in favor of the motion with Batty abstaining from the vote.

Bud Smith and Don Horton, representing the Rotary Club appeared before the Council and said that they wished to place a plaque honoring servicemen killed in action some where in the City Hall area. This plaque will be maintained and updated by members of the Rotary Club. Lloyd Mosier made a MOTION that the Rotary Club be given permission to follow through with this idea. Henry Kerr seconded the motion which was carried unanimously.

Gilbert Batty made a MOTION that liability insurance bids be advertised for to be opened at the March 12 Council meeting, and that the possibility of establishing an agent of record be considered. Lloyd Mosier seconded the motion which met with unanimous approval.

City Draftsman Jerry Swanson submitted a map and cost sheets pertaining to the sewerage of additional homes in the Buena Vista Loop area. Bob Swanson indicated that his crew should be able to do the work involved. Lloyd Mosier said that the city had no alternative but to go ahead with this project, and made a Motion that the city do so. Henry Kerr seconded the motion which was unanimously accepted.

Jerry Swanson also pointed out that there are presently 128 street lights in the city. Lights which are paid for by the city cost of \$50 each per year.

Use of the multi-purpose room by various organizations was once again discussed. Mayor Manley said he would contact the City of Gold Beach as to how they are handling the use of their facilities, and that he would also write the Chamber of Commerce a letter pertaining to their request for use of facilities in the Brookings City Hall.


The possibility of raising \$30,000 in funds for construction of the proposed community center building was discussed. Councilman Mosier questioned placing the City of Brookings under the burden of financing and maintaining the building, and suggested the formation of a separate parks and recreation district. Councilman Batty suggested that the local news media conduct a poll to get the feeling of the public on this matter.

Roy Weideman appeared before the Council and discussed the possibility of turning the contract of a house on one of his lots, with a balance of \$8,504 owing, to the city to be applied toward his assessments. The Council indicated they would discuss this with the hopes that something could be worked out by the next meeting.



Mayor Manley said that if the city entered into the water business they would serve those who presently have no water service.

Vouchers totaling \$6,811.74 were submitted for payment. Gilbert Batty made a MOTION that the vouchers be paid. Following a second by Lloyd Mosier, the motion was carried unanimously.


PLANNING COMMISSION RECOMMENDATION

SUBJECT: Decision Alfred Sulmonetti

In order that the Municipal Judges Association of the State of Oregon may voice its opinion in the forthcoming public hearing to be held in Portland, Multnomah County Courthouse, Commissioner's Meeting Room, Friday, February 23, 1968, at 9:30 a.m., I find it necessary to, by mail, solicit your views, opinions and ideas and recommendations concerning Judge Alfred Sulmonetti's decision in Portland of recent date.

That decision holds that an indigent misdemeanor defendant is entitled to a free lawyer and a free jury trial where a jail sentence may be imposed in the Municipal Court or Justice Court.

Frank Bocci, Municipal Judge in Eugene, is working on the problem of a free jury trial to indigents and will make a report concerning same. He has been asked to appear before the Judicial Council for the State of Oregon who are holding a hearing and make known the results of his investigation.

I am going to pose four questions for your consideration. (I know there could be more, but we are working against a deadline.)

How does your city feel about the indigent problem posed by the recent Court decision in Oregon (Albert Sulmonetti, Circuit Court, Multnomah County, Oregon)?

How does your city plan to cope with this problem?

How does your city feel about furnishing the defendant, when represented by this free attorney, if that be the case, receiving a free jury trial?

How does your city plan to cope with the problem?

I would like to have you answer these questions that I have posed and conclude with your written opinion as to what we should recommend to the Judicial Council from our Association.

We will have to tabulate the views and for this purpose I propose to have Evelyn Scott, the Secretary in Salem, and Frank Bocci, the Vice-President in Eugene, and myself meet to count the results.

Please do not put this letter away. I, too, feel that I can do this tomorrow when I have more time but if you take the time to do it now, it's done with and we will have something concrete to present to the Judicial Council.

Please plan on attending the annual meeting in Eugene coming up soon. We are working on the Constitution and By-Laws and the dues-paying structure through Evelyn Scott in Salem and we will need the benefit of your experience and wisdom in your position as Judges.
