MINUTES OF THE REGULAR COUNCIL MEETING CITY OF BROOKINGS MARCH 14, 1967

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present were Lloyd Mosier, Alden Loring, and Gilbert Batty.

Reporters present were Dick Keusink, Marge Barrett, and Ruth Brewer.

Minutes of the February 14 Council meeting were read and approved.

Letters from the Sidney Croft Lodge and the Brookings Fire Department were read and are attached hereto.

Resolution No. 124 authorizing a property foreclosure was read to the Council Lloyd Mosier made a MOTION that Resolution No. 124 be accepted. Gilbert Batty seconded the motion and it was unanimously carried.

Planning C ommission No. 119 was read to the Council. Following considerable discussion regarding the street width, the Council decided to table this item until the next meeting.

Planning Commission No. 120 was read. Lloyd Mosier made a MOTION that the petition for rezoning be accepted. Alden Loring seconded the motion and it was unanimously approved.

Planning Commission Recommendation No. 121 was read and discussed. Mayor Manley said that he and Chief of Police C. M. Cross will contact the State Highway D epartment Resident Engineer in an effort to see what can be done and have a report on this item at the A pril 11 Council meeting.

Bids were opened and read on foreclosed Parcel No. 1, better described as map no. 41-13-5BB, tax lot 3500. Brook-Pac Investments submitted a bid of \$2,002.51 and Willard Stoker submitted a bid of \$2,510.00. Alden Loring made a MOTION that the bid of Willard Stoker for \$2,510.00 be accepted. Lloyd Mosier seconded the motion and it was unanimously carried.

John Ebinger submitted the only bid on Parcel No. 2, Better described as map no. 41-13-6BA, tax lot 300. Alden Loring made a MOTION that the bid of \$10,036.70 submitted by John Ebinger be accepted. Lloyd Mosier seconded the motion and it met with unanimous approval.

Bids for liability insurance were opened and read. Fauerso Lesmeister Agency submitted a bid of \$1,942.00. Gerald Ross Insurance Agency submitted a bid of \$1,750.00 Lloyd Mosier made a MOTION that the lower bid of \$1,750.00 submitted by Gerald Ross Insurance Agency be accepted. Gilbert Batty seconded the moting and it was unamimously accepted.

Gilbert Batty made a MOTION that the City of Brookings approve installation of a street light at the corner of Alder and Birch Streets. Lloyd Mosier seconded the motion and it was approved unanimously.

The date of the first Budget Committee meeting was tentatively set for Monday, May 8.

Gilbert Batty made a MOTION that Building Inspector Lee Fountain be permitted to attend the annual Building Inspectors School in Corvallis March 30, 31 and April 1. Lloyd Mosier seconded the motion which met with unanimous approval.

Vouchers totaling \$4,745.20 were submitted for payment. Lloyd Mosier made a MOTION that the vouchers be paid. Gilbert Batty seconded the motion, and it was unanimously carried.

The meeting was then adjourned at 9:03 P. M.
