

MINUTES OF THE REGULAR COUNCIL MEETING
CITY OF BROOKINGS
APRIL 11, 1967

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present were Lloyd Mosier, Alden Loring and Gilbert Batty.

Reporters present were Marge Barrett, Ruth Brewer and Dick Keusink

A letter of resignation from Ed Thornton was read to the Council. Lloyd Mosier made a MOTION that the Council accept the resignation of Ed Thornton. Alden Loring seconded the motion, and it met with unanimous approval.

Planning Commission Recommendation No. 122 was read to the Council. Lloyd Mosier made a MOTION that Planning Commission Recommendation No. 122 be accepted. Gilbert Batty seconded the motion, and the appointment of Robert O. Dimmick, Sr. to the Planning Commission was unanimously approved.

Planning Commission Recommendation No. 123, dealing with the proposed Bureau of Municipal Research Planning Study, was read to the Council. Much discussion followed regarding this Recommendation. Mayor Manley stated that this was pretty much a study program. Following further discussion between members of the Council and interested persons in attendance at the meeting, Gilbert Batty made a MOTION that this item be tabled until the next Council meeting, and no longer. Alden Loring seconded the motion, and it was unanimously carried.

A letter from Elmer Keusink was read and is hereto attached.

A Retail Class A Malt Beverage License application from the Pizza King was presented to the Council for approval. Lloyd Mosier made a MOTION that the Council approve the application, Alden Loring seconded the motion and it met with unanimous approval.

Police Chief C. M. Cross gave a report on the crossing at Oak Street and Highway 101. He said that some form of stop light is definitely needed at that location. Lloyd Mosier made a MOTION that this item be tabled in order to allow discussion with representatives of the State highway department on the subject. Alden Loring seconded the motion which was approved unanimously.

A final report of the Planning Commission on a zone change was read to the Council and attached hereto. Gilbert Batty made a MOTION that the report be accepted, and a special use permit be issued to the Brookings Congregation of Jehovah's Witnesses as was recommended in the report. Alden Loring seconded the motion, which was unanimously carried.

Plans for an addition to the Chetco Community Library were presented to the Council. This is to be a 19' x 21' addition onto the existing facility. It was pointed out that since the library is a City-owned building, the Council should approve the plans. Alden Loring made a MOTION that the plans for the proposed addition onto the Chetco Community Library be approved. Lloyd Mosier seconded the motion which met with unanimous approval.

Discussion took place regarding abandoned cars within the City limits. It was agreed that something should be done about them, but the question of what to do with the cars once the City collected them still remained.

Curry County Commissioner H. E. Timeus appeared before the Council and spoke briefly on the Sidney Croft Lodge cornerstone laying ceremony.

It was pointed out that the terms of three of the members of the Planning Commission expire on April 21. Lloyd Mosier made a MOTION that Jack Holte and Gerald Ross be reappointed to their terms of office. Gilbert Batty seconded the motion which was unanimously approved. It was decided to let the Planning Commission recommend to the Council at their next meeting who they wished to fill the other vacancy, as Ed Oar did not wish reappointment.

Alden Loring made a MOTION that Municipal Judge Mary M. Beinke be permitted to attend the Oregon Traffic Court Conference being held in Eugene on April 27, 28 and 29. Gilbert Batty seconded the motion which was carried unanimously.


Gilbert Batty made a MOTION that City Recorder Robert O. Dimmick, Jr. be permitted to attend the Oregon Association of City Finance Officers meeting which is to be held in Salem on May 11 and 12. Alden Loring seconded the motion which was unanimously approved.

Building Inspector Lee Fountain gave the location of several buildings in town which were abandoned, delapidated and generally fire traps. He recommended that City Attorney W. W. Balderree notify the owners and request that the sub-standard structures be removed. Lloyd Mosier made a MOTION that the recommendation of Building Inspector Lee Fountain be accepted, and that City Attorney W. W. Balderree so notify the owners of the structures. Alden Loring seconded the motion which met with unanimous approval.


It was pointed out that the first Budget Committee meeting will be held on Monday, May 8, at 8:00 P. M.

Vouchers totaling \$4,700.65 were presented to the Council for payment. Lloyd Mosier made a MOTION that the vouchers be paid. Following a second by Alden Loring, the motion was unanimously accepted.

The meeting was then adjourned at 9:25 P. M.



The City Planning Commission does hereby file its final report regarding the zoning of that parcel of property designated as follows:

Tax lot 200-41-13-6BB, as described in that certain Legal Notice of Hearing published March 30, 1967, in the local news media.

On April 4, 1967, after due notice and pursuant to the provisions of Ordinance No. 19, the City Planning Commission did hold a public hearing on the above described zoning proposal, to give all persons interested and the general public an opportunity to be heard on the proposed change in zoning.

A representative of the Brookings Congregation of Jehovah's Witnesses was present to speak in favor of the proposed zone change. There were no protests or objections made.

In view of the above findings and after due consideration, the City Planning Commission hereby recommends in this final report that the City Council thoroughly investigate this situation and, if feasible, a special permit be issued for the construction of the proposed Church.
