

MINUTES OF THE REGULAR COUNCIL MEETING
CITY OF BROOKINGS
OCTOBER 11, 1966

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present were Lloyd Mosier, Ernest Christensen, Henry Kerr, and Ben Franklin.

Reporters present were Marge Barrett, Ruth Brewer, and Dick Keusink.

Minutes of the September 13 Council meeting were read and approved.

The proposed agreement between the City of Brookings and Curry County regarding construction of the new City Hall was read to the Council. Ernest Christensen made a MOTION that the agreement be endorsed by the City of Brookings. Ben Franklin seconded the motion, and it passed with unanimous approval.

Ordinance No. 188 was read to the Council in its entirety. A MOTION was made by Ernest Christensen that the rules be suspended and an emergency be declared and that Ordinance No. 188 be read the second time by title only. The Ordinance was then read the second time by title only. Lloyd Mosier then made a MOTION that Ordinance No. 188 be read the third time by title and declaring an emergency be placed upon its final passage and that it be in full force and effect from and after its passage. Ernest Christensen seconded the motion and it was carried unanimously. Following the reading of the Ordinance the third time by title only, the following vote resulted:

Absent: None

Ordinance No. 188 having received the required number of votes, the Mayor declared the same to have duly passed and to have been duly adopted.

Specifications for a 1967 police car were presented to the Council. Ernest Christensen made a MOTION that the City of Brookings advertise for bids for a new police car to be opened at 8:00 P. M. on November 9, 1966. Henry Kerr seconded the motion and it carried unanimously.

Roy Erichsen presented plans and elevations of the new City Hall. The building will contain approximately 9,344 square feet. Based on the present amount of money available, Mr. Erichsen pointed out this would be an estimated \$12.20 per square foot estimated cost, which would be a rather tight budget. The Mayor and Council indicated they would review the available finances. A meeting was called for October 25, at which time Mr. Erichsen would present final plans of the new City Hall. Ernest Christensen made a MOTION that bids for the new City Hall be advertised October 27 and November 3, and that they be opened 7:00 P.M. November 17 at the Brookings City Hall. Ben Franklin seconded the motion and it met with unanimous approval.


Fire Chief Bob Kerr said that Curry County Communications was now answering fire calls for both the Brookings and Harbor fire departments. It was pointed out that this service costs the City of Brookings \$75 per month, of which \$25 is for answering and \$50 is for radio service. It was also pointed out that the Harbor Rural Fire Department pays \$25 per month for answering and nothing for radio service. Ernest Christensen made a motion that the Harbor Rural Fire Department pay \$25 per month for radio dispatching service. Lloyd Mosier seconded the motion and it was carried unanimously.

It was pointed out that the Shell Station was going to install some new tanks and that the existing tanks were going to be filled with sand and concrete. Ben Franklin made a MOTION that the Council go on record as saying that the existing tanks should be removed and the street returned to its original condition. Ernest Christensen seconded the motion and it was unanimously passed.




The City Attorney also said that since there was some question as to whether or not all the witnesses would be available, and also because he was faced with a time problem, he requested a continuance of the Elmer Bankus Vs. City of Brookings case and that continuance was granted.

Vouchers totaling \$4,631.12 were submitted for payment. Ben Franklin made a MOTION that the vouchers be paid. Ernest Christensen seconded the motion and it was unanimously passed.

Following a MOTION by Ernest Christensen and a second by Ben Franklin, the meeting was adjourned at 9:25 P. M.
