

MINUTES OF THE REGULAR COUNCIL MEETING
CITY OF BROOKINGS
NOVEMBER 9, 1966

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present were Henry Kerr and Lloyd Mosier.

Reporters present were Marge Barrett, Dick Keusink and Ruth Brewer.

The minutes of the October 11 and October 26 Council meetings were read and approved.

It was pointed out that Roy Erichsen desired to meet with the Council and review the bidders pre-qualification forms. the date of this meeting will be announced later.

A petition objecting to the fire siren and horns blowing at noon was presented to the Council. Fire Chief Bob Kerr stated that this gave the City a 24-hour check on their alarm system. He also pointed out that the alarm is not being blown for such a long period now. Some of the signers of the petition who were present indicated that they had no objections now that the length of time that the siren and horns blew was cut down.

An Abstract of votes of the City election was presented to the Council for canvass. A copy of the abstract is attached hereto.

Bids for a new 1967 police car were opened and read. Akin Motor Co. bid \$2,611.20 less trade for a net of \$1,411.20 Chetco Motor Co. bid \$2,521.60 with no trade allowance, and a bid of \$2,489.15 with no trade allowance. Richard Chevrolet-Buick bid \$2,489.63 less trade for a net of \$985.63. Lloyd Mosier made a MOTION that the bid of \$985.63 with trade in of the old police car be accepted. Henry Kerr seconded the motion, and it was unanimously carried. It was stated by the representative of Richard Chevrolet-Buick present at the meeting that the City will be able to keep their present police car until the new one is received.

Lloyd Mosier made a MOTION that liquor license renewal applications be accepted for C & K Market, McKays Market, Green Door, O'Holleran's, Ken's Tavern, Jim & Al's Brookings Market, Pine Cone Tavern, and B.P.O.E. #1934. Henry Kerr seconded this motion and it was passed unanimously.

Condemnation of several buildings was discussed by Building Inspector Lee Fountain. Henry Kerr suggested that this matter be tabled until after January 1.

City Draftsman Jerry Swanson reported that the Palm Stout property is ready to be surveyed. It was pointed out by the City Draftsman that, unopened portions of Cedar, Cypress, Maple, and Oxford Streets should be opened up. Since the Memory Lane Lift Station bond issue has passed, the City Draftsman wished to authorize the firm of Harlan, Gessford, and Erichsen to begin final plans on the station.


The State of Oregon indicated that they wished to cancel the remaining portion of their Department of Motor Vehicles-P.U.C. lease. After some discussion, it was decided that the Council would not release the State of Oregon from the remainder of their lease.

Lloyd Mosier made a MOTION that the City Hall close November 25, the day following Thanksgiving. Henry Kerr seconded the motion and it met with unanimous approval.

City Attorney Bill Baldrree was instructed to draw up an Ordinance regarding the sale of bonds for the Memory Lane Lift Station.



The meeting was then adjourned at 9:10 P. M.

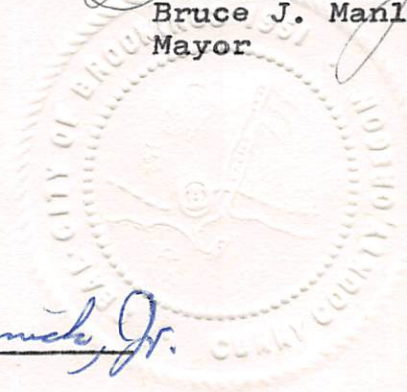
