

MINUTES OF THE REGULAR COUNCIL MEETING  
CITY OF BROOKINGS  
DECEMBER 13, 1966

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present included Ernest Christensen, Ben Franklin, Lloyd Mosier and Henry Kerr.

Reporters present were Marge Barrett and Dick Keusink.

Minutes of the November 9, November 21, November 22, and November 29 Council meetings were read and approved.

A letter from the Chetco Community Library was read to the Council and is attached hereto. Ernest Christensen made a MOTION that the recommendations of the Library Board be appointed to the Board of Trustees for four year terms. Henry Kerr seconded the motion and it was unanimously passed.

Letters from the Department of Motor Vehicles and Harley Nissen were read and attached hereto. Lloyd Mosier made a MOTION that the resignation of Harley Nissen be accepted. Henry Kerr seconded the motion and it was passed unanimously. Mayor Manley requested that a letter of appreciation be sent to Harley Nissen.

A letter from Red's Body Shop requesting permission to construct a paint spray booth was read. It was decided by the Council that a paint spray booth, in conformance with the Uniform Building Code, can be constructed in an M-1 Zone.

Planning Commission Recommendation No. 117 was read to the Council. Following considerable discussion, Ben Franklin made a MOTION that Planning Commission Recommendation No. 117 be accepted. Henry Kerr seconded the motion and it was carried unanimously.

Ben Franklin made a MOTION that the City of Brookings advertise for gas bids to be opened at 8:00 P. M. January 10, 1967. Lloyd Mosier seconded the motion and it met with unanimous approval.

City draftsman Jerry Swanson said that Lloyd Bunnell requested some curbing installed in front of his house on Pacific Avenue. This would be done at the expense of Lloyd Bunnell and completed to City specifications. Ben Franklin made a MOTION that this request be accepted. Following a second by Lloyd Mosier, the motion was unanimously carried.

The problem as to whether or not any more properties could hook onto the Tanbark outfall line was discussed. It was pointed out that as long as the assessments had been paid, the City could not prevent them from hooking on.

An Engineering contract for the proposed municipal water system was presented and discussed. Lloyd Mosier made a MOTION that the contract be accepted and that the Mayor and Recorder sign and submit the contract to the Farmers Home Administration for approval. Ben Franklin seconded the motion and it met with unanimous approval.

Ordinance No. 189 was read to the Council in its entirety. A MOTION was made by Ernest Christensen that the rules be suspended and an emergency be declared and that Ordinance No. 189 be read the second time by title only. The ~~motion~~ <sup>ORDINANCE</sup> was seconded by Ben Franklin and carried unanimously. The ~~motion~~ <sup>ORDINANCE</sup> was then read the second time by title only. Lloyd Mosier then made a MOTION that Ordinance No. 189 be read the third time by title only and declaring an emergency be placed upon its final passage and that it be in full force and effect from and after its passage. Henry Kerr seconded the motion and it was unanimously passed. Following the reading of the Ordinance the third time by title only, the following vote resulted:

Absent: None

Ordinance No. 189 having received the required number of votes, the Mayor declared the same to have duly passed and to have been duly adopted.



Since there is quite a bit of foot traffic in the area, a very dangerous situation exists. The City Recorder was instructed to write the owner a letter informing him of the hazard and requesting that it be taken care of.

Mayor Manley praised the two outgoing Councilmen for their work the past six years and said that their work has been greatly appreciated. Police Chief C. M. Cross wished to congratulate the two outgoing Councilmen for the fine job which they have done.



Retiring board members are Mrs. Dorothy Hermann and Mrs. Marion Harris.

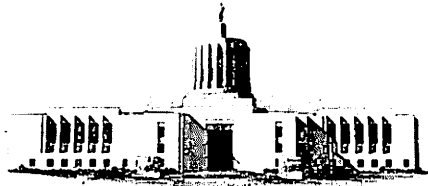






PLANNING COMMISSION RECOMMENDATION
