

CITY OF BROOKINGS  
MINUTES OF THE REGULAR COUNCIL MEETING  
FEBRUARY 9, 1965

MEETING CALLED TO ORDER AT 8:00 P. M., MAYOR BRUCE J. MANLEY PRESIDING. COUNCILMEN PRESENT: BEN FRANKLIN, JR., ERNEST CHRISTENSEN, HENRY KERR AND LLOYD MOSIER. REPORTERS PRESENT: DICK KUESINK, MARGE BARRETT AND RUTH BREWER.

MINUTES OF THE JANUARY 21ST COUNCIL MEETING WERE READ AND APPROVED AS READ, AFTER CORRECTION.

BIDS FOR FURNISHING STOVE OIL AND DIESEL FUEL FOR USE IN CITY BUILDINGS AND EQUIPMENT FOR THE 12 MONTH PERIOD COMMENCING FEBRUARY 15, 1965, WERE OPENED. BIDS WERE RECEIVED FROM RICHFIELD OIL CORP AND UNION OIL CO. THE LOW BID OF \$.1358 AND \$.1298 WAS SUBMITTED BY UNION OIL CO.

MOTION BY BEN FRANKLIN, JR. THAT THE LOWEST BID, SUBMITTED BY THE UNION OIL CO. BE ACCEPTED. SECONDED BY ERNEST CHRISTENSEN, MOTION CARRIED.

MOTION BY LLOYD MOSIER THAT THE RECORDER'S OFFICE ADVERTISE FOR BIDS FOR BLANKET LIABILITY INSURANCE. SECONDED BY BEN FRANKLIN, JR. MOTION CARRIED.

UPON RECOMMENDATION OF POLICE CHIEF CROSS AND CITY DRAFTSMAN, JERRY SWANSON, THE CITY COUNCIL AUTHORIZE THE PURCHASE OF THE NECESSARY ASPHALT TILE TO BE USED FOR THE MARKING OF THE CROSS WALK AT OAK AND U. S. 101 HWY. THIS PURCHASE IS SUBJECT TO THE APPROVAL OF THE STATE HIGHWAY DEPARTMENT. APPROX. COST WAS ESTIMATED AT \$75.00.

MOTION BY BEN FRANKLIN, JR. THAT THE COUNCIL ACCEPT THE RECOMMENDATION SUGGESTED BY POLICE CHIEF AND CITY DRAFTSMAN. SECONDED BY ERNEST CHRISTENSEN. MOTION CARRIED.

THE CITY DRAFTSMAN REPORTED THAT FUNDS FOR CITY STREET IMPROVEMENT ARE NOW AVAILABLE FROM THE STATE HIGHWAY DEPARTMENT AND THAT HE HAS WRITTEN OFF FOR THE NECESSARY APPLICATION.

AMENDMENTS TO ORDINANCE No. 50 GOVERNING STREET PAVEMENT CUT REQUIREMENTS WAS DISCUSSED BRIEFLY. THE COUNCIL WAS IN AGREEMENT THAT CHANGES ARE NEEDED AND THE CITY DRAFTSMAN AND STREET SUPT. WERE INSTRUCTED TO REVIEW THE PROPOSED AMENDMENTS AND REPORT BACK AT THE NEXT MEETING.

THE CITY DRAFTSMAN INFORMED THE COUNCIL THAT HE HAD WRITTEN A LETTER TO THE HOUSE AND HOME FINANCE AGENCY REQUESTING NECESSARY FORMS AND APPLICATIONS FOR ADVANCED PLANNING ALLOCATIONS FOR THE ENGINEERING PREPARATION OF A NEW MASTER SEWER PLAN AND A NEW MASTER STREET PLAN.

A REPORT GIVEN BY LEE FOUNTAIN, BLDG. INSPECTOR, STATED THAT THE STATE FIRE MARSHALL AND THE FIRE CHIEF BOB KERR CAME TO THE CONCLUSION THAT THE SPRAY PAINT BOOTH CONSTRUCTION LOCATED IN MR. GULLEY'S PROPERTY AT WHARF AND SPRUCE STS, IS UNABLE TO BE CONTINUED. THIS CONSTRUCTION DOES NOT CONFORM WITH THE UNIFORM BUILDING CODE.

OTHER MATTERS::

MRS. ZONA GEANEY APPEARED AT THE COUNCIL MEETING AND REGISTERED A COMPLAINT OF EXCESSIVE NOISE IN THE AREA OF HER HOME, PARTICULARLY AT MR. WOODS AND MR. ARCHIBALDS PROPERTY WHERE TRUCK MAINTENANCE IS BEING CARRIED ON. THIS NOISE IS AT LATE HOURS OF THE NIGHT AND ON HOLIDAYS AND SUNDAYS. HAROLD COOPER AND JACK ROSS WERE ALSO PRESENT AT THE COUNCIL MEETING AND WERE IN AGREEMENT WITH MRS. GEANEY. THEY DO NOT WISH TO HINDER ANY PERSONS LIVELIHOOD BUT WISH THAT SOME AGREEMENT COULD BE ARRANGED TO THE HOURS OF THIS MAINTENANCE WORK DONE ON THE TRUCKS SO THAT THEY CAN GET THERE REST.

THE REQUEST BY MRS. JULE WERSCH ASKING FOR PERMISSION TO BUILD A 10'x16' ROOM ADDITION TO HER TRAILER HOUSE WAS REFERRED TO THE PLANNING COMMISSION FOR APPROVAL.

THE TANBARK SITUATION WAS AGAIN DISCUSSED. THE MAYOR AND COUNCIL INFORMED THE ATTENDING CITIZENS OF THIS LOCALITY THAT THIS SITUATION IS STILL UNDER STUDY.

FROM THIS UNIT ONLY POPCORN, PEANUTS AND SNOW CONES WILL BE SOLD. MOTION SECONDED BY BEN FRANKLIN, JR. MOTION CARRIED.

MOTION BY ERNEST CHRISTENSEN FOR PAYMENT OF VOUCHERS TOTAL OF \$4,076.32 BE PAID. MOTION SECONDED BY HENRY KERR. MOTION CARRIED. LIST ATTACHED.
