

SPECIAL BUDGET COMMITTEE MEETING  
CITY OF BROOKINGS, OREGON  
SEPTEMBER 9, 1965

At the request of the Auditor of the City of Brookings, a special meeting of the Budget Committee was held at the City Hall. The meeting was called to order at 7:40 P. M. by Mayor Bruce Manley.

The Auditor told the Committee that the budget was in excess of the 6% limitation, and that it was necessary for him to refer it back to the Budget Committee for the necessary changes. The exact figure that the budget was in excess was stated by the City Recorder to be \$12,605.45.

It was pointed out that one of the figures in question was a \$7,000.00 serial levy. This levy was to have begun in the fiscal 1960-61 year and lasted for a five year period, thereby expiring at the end of the 1964-65 fiscal period. This figure appeared in the 1965-66 budget by error. The remainder of the budget excess was brought about by an error in computation.

A Motion was made by Ben Franklin, Jr. that the Auditor and City Recorder be authorized to make the necessary entries to bring the budget within the 6% limitation. This Motion was seconded by Ernie Christensen and was unanimously approved by the Budget Committee.

The meeting was then adjourned at 8:00 P. M.


Before beginning construction on the above-mentioned building, we requested sidewalk and curb elevations from your city engineer. We built the sidewalks and curbs according to the elevations that he gave us.

At that time, we were advised that it was the intent of the City to lower the grade of the street to meet the elevation of the improved adjoining street. We were not interested in participating in a local improvement district. However, we did go to the expense of installing curbs and sidewalks.

Under these circumstances, we request that you give serious consideration to the possibility of just lowering the grade of the street and putting in a temporary gravel cut similar to what you presently have. We were advised by Pacific Rock and Paving Company that this should cost less than \$500.

Gentlemen:

The Brookings Parks and Recreation Commission request authorization from the Brookings City Council to negotiate for the acquisition of land offered by Mrs. Palm Stout to the City.


Your authorization will permit the Parks and Recreation Commission to work out details and conditions for the transfer which would be mutually acceptable to both Mrs. Stout and the City. It is further understood by this Commission that any and all decisions would be subject to a final approval and acceptance by the Council.

The potential improvements and expense are unknown at this time. However, the Parks and Recreation Commission feels that all financial aspects should be approached on a self-supporting basis and community effort, and not as a tax supported venture.

The subject land is ideally located with excellent access to all areas of the City. The terrain and natural beauty of the property are well suited to the eventual development of a city park, community building and recreational playground.

Your authorization and support are earnestly requested so that we may arrange for an orderly conclusion of the negotiations and early presentation to the Council.


