MI NUTES OF THE REGULAR COUNCIL MEETING CITY OF BROOKINGS NOVEMBER 9, 1965

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present were Ernest Christensen, Henry Kerr, Ben Franklin, Jr., and Lloyd Mosier.

Reporters present were Jean Nulf, Ruth Brewer, Dick Keusink, and Marge Barrett.

The minutes of the previous meeting were read and approved.

Planning Commission Recommendation No. 107 was read to the Council. Lloyd Mosier made a MOTION that the Council accept this Recommendation. The motion was seconded by Ben Franklin, Jr. and unanimously passed.

Ben Franklin, Jr. made a MOTION that the City Hall close November 26, the day after Thanksgiving. This was seconded by Lloyd Mosier and passed unanimously.

Chief of Police Bud Cross spoke on non-payment of City License. He pointed out that many businesses have not yet purchased their 1965-66 City License. He said that the present ordinances dealing with this are too lenient. The Council instructed City Attorney pro-tem David Fortier to give a recommendation regarding this situation at the next regular Council meeting.

Ernest Christensen made a MOTION that liquor license renewal applications be accepted for Green Door, Pine Cone Tavern, C & K Market, O'Hollerans, Ken's Tavern, Dimmick Bros. Market, B.P.O.E. # 1934, and McKays Market. This was seconded by Ben Franklin and unanimously accepted.

It was pointed out that the Civil Defense materials which the City borrowed during the recent water shortage should be sent back. A MOTION was made by Ernest Christensen that Supt. of Public Works Bob Swanson be appointed to pack and ship the pipe, pump, and chlorinator back to Ordinance. This was seconded by Henry Kerr and met with unanimous approval.

The engineers report recently submitted by Cornell, Howland, Hayes and Merryfield was discussed. It was pointed out that the proposed water system would take in every area of the town. Henry Kerr said that he felt a revenue bond issue for \$885,000 would be adequate. Following further discussion on the matter, Ernest Christensen made a MOTION that the City Attorney draw up the necessary papers for a revenue bond issue for purpose of establishing a municipal water system. This was seconded by Ben Franklin, Jr. and unanimously passed.

Ernest Christensen made a MOTION that Henry Kerry be delegated to check into the rental of a suitable tape recorder with the objective to purchase after the 1966-67 budget has been passed. The motion was seconded by Ben Franklin, Jr. and passed unanimously.

Vouchers totaling \$3,045.54 were submitted to the Council for approval. Ernest Christensen made a MOTION that the bills be paid which was seconded by Lloyd Mosier and passed unanimously.

Ernest Christensen then made a MOTION that the meeting be adjourned until 8:00 P. M. Friday, November 19, in order that City Attorney pro-tem David Fortier can have adequate time to draw up the necessary papers for placing the water bond issue to the vote of the people. This motion was seconded by Ben Franklin, Jr. and unanimously approved.
