MINUTES OF THE REGULAR COUNCIL MEETING CITY OF BROOKINGS, OREGON DECEMBER 14. 1965

The meeting was called to order at 8:00 P. M. by Mayor Bruce J. Manley.

Councilmen present were Lloyd Mosier, Ernest Christensen, Ben Franklin, Jr. and Henry Kerr.

Reporters present were Dick Kuesink and Marge Barrett.

The minutes of the previous council meetings were read and approved.

It was pointed out that the term of Doris Crosby on the Board of Trustees of the Chetco Community Public Library expires December 31, 1965. Ernest Christensen made a MOTION that she be reappointed to this position. It was seconded by Lloyd Mosier and passed unanimously.

A letter from the Commerical Leasing Co. was read to the Council requesting that Oxford Street be opened. The Council referred this request to the Planning Commission.

Vern Garvin, representing Curry County Communications, discussed the possibility of obtaining a franchise for cable television in this area. He stated this would guarantee a good picture for a least three stations and possibly four. The Mayor requested City Attorney pro-tem David Fortier to study the matter.

Ralph Robertson, who represents the United States Post Office Department, appeared before the Council. He asked for the consideration and help of the Council in resolving the problem on Spruce Street in front of the Post Office. It was pointed out by Mr. Robertson that the curb and existing drop-off creates a tremendous safety problem in addition to a drainage problem. Several possible solutions to the problem were discussed among the Council and Mr. Robertson, but none appeared to be exactly feasible. The Council was in agreement that something should be done to correct the situation, but did not know exactly what would be possible at the moment.

City Draftsman Jerry Swanson discussed his attendance at a Public Works short course in Medford, The Council did not feel this would be too beneficial, however, and instructed him to write to the League of Oregon Cities and find what specialized schools are available in his capacity.

Photostats of the bills incurred by the City of Brookings during the recent water crisis were presented to the Council. These bills, which totaled \$1,718.12 were paid through the emergency fund of the Curry County Court. The Council instructed the City Recorder to write a letter to the Curry County Court thanking them for their assistance, A MOTION was made by Ben Franklin, Jr. and seconded by Ernest Christensen that the Brookings Water Company be sent a memo on this billing. The money, if collected, would be returned to the Curry County Court. The motion was passed unanimously.



Vouchers totaling \$3,473.60 were submitted to the Council for paymant. A MOTION was made by Ben Franklin, Jr. and seconded by Lloyd Mosier that the bills be paid. This was unanimously passed.

Ben Franklin, Jr. then made a MOTION that the meeting be adjourned. This was seconded by Lloyd Mosier and passed unanimously. The meeting was adjourned at 9:15 P. M.
