

CITY COUNCIL...MEETING...SPECIAL SESSION...FRIDAY, JUNE 14, CITY HALL


THE SPECIAL MEETING OF THE CITY COUNCIL WAS CALLED TO ORDER FRIDAY, JUNE 14 AT THE CITY HALL WITH ALL MEMBERS OF THE COUNCIL PRESENT. ALSO PRESENT WAS CURRY COUNTY JUDGE C. F. CAMPBELL AND COUNTY COMMISSIONER WILLIAM CAMPBELL AND FRANK HARRISON AND BOB PATERSON-FOX. REPORTERS PRESENT BARRETT, KEUSINK AND BREWER.

MAYOR ROBERT O. DIMMICK PRESIDED OVER THE SESSION AND OPENED THE MEETING BY SAYING THE SPECIAL SESSION WAS CALLED FOR THE EXPRESS REASON OF DISCUSSING THE COUNTY-CITY PAVING PROJECT FOR BROOKINGS CITY STREETS.

BOTH JUDGE CAMPBELL AND COMMISSIONER CAMPBELL ASSURED THE COUNCIL THAT THE PAVING PROGRAM WOULD BE CARRIED OUT THIS YEAR JUST AS IT HAS IN THE PAST TWO YEARS. JUDGE CAMPBELL EMPHASIZED THE STATEMENT OF POLICY WAS NOT A CONTRACT BUT MERELY WRITTEN REGULATIONS UNDER WHICH THE PROGRAM HAS OPERATED IN THE PAST. HE SAID THAT ALL THE STREETS IN BROOKINGS WHICH HAVE BEEN REQUESTED BY THE CITY FOR PAVING HAVE ALREADY BEEN APPROVED BY THE COUNTY ROADMASTER.

COUNCILMAN BEN FRANKLIN, JR. PRAISED THE PROGRAM AND STATED THAT IT HAS PUT THE CITY AHEAD 8 TO 10 YEARS IN STREET PAVING. "THERE IS NO QUESTION OF THE GOOD OF PROGRAM," HE STATED AND INDICATED THAT HIS ONLY OBJECTION WAS TO THE WORDING OF THE POLICY STATEMENT.

THE CITY COUNCIL TOOK NO ACTION BUT IT WAS GENERALLY UNDERSTOOD THAT THE STREET PAVING PROGRAM WOULD BE CONTINUED ON THE SAME BASIS AS THE PAST TWO YEARS WITH THE CITY PREPARING THE STREETS AND THE COUNTY FURNISHING THE LABOR AND MATERIAL AND EQUIPMENT TO LAY THE OIL SURFACING.
