CITY OF BROOKINGS MINUTES OF THE REGULAR COUNCIL MEETING October 8, 1963

Meeting called to order at 8:00 P. M., Mayor Robert O. Dimmick presiding. Councilmen present; LeRoy Weideman, Henry Kerr and Ernest Christensen. Absent; Ben Franklin, Jr.

Reporters present; Brewer, Kuesink and Oberst.

Minutes of the previous regular and special council meetings were read and approved as read.

Planning Commission Recommendation No. 73—Motion by Ernest Christensen that Recommendation #73 be adopted. Seconded by LeRoy Weideman. Motion Carried by all present.

Opening of bids—The only bid was submitted by the Akin Motor Co., to furnish a 1964 ford police cruiser four door sedan, equipped to meet or exceed all required specifications at a price of \$2,481.00 with an allowance of \$1,500.00 for the present car, and a net difference of \$ 981.00.

MOTION by LeRoy Weideman that the Bid of Akin Motor Company be accepted. Seconded by Ernest Christensen. Motion carried by all present.

A second tentative report from the Planning Commission, regarding proposed zone change was read. It was noted that a final report on the proposal would be submitted at a subsequent date, after the commissioners have had an opportunity to personally inspect the property and the general area and give more study to the matter.

Ordinance #173-Zone Change. Ordinance Number 173 was read in full. MOTION by Ernest Christensen that the rules be suspended and an emergency declared and that the ordinance be read the second time by title only. Motion seconded by Councilman Weideman. Motion carried then the ordinance was read the second time by title. MOTION by Councilman Christensen that it be read a third time by title and declaring an emergency be placed upon its final passage and that it be in full force and effect from and after its passage. Motion seconded by LeRoy Weideman. Motion carried. The ordinance was then read the third time be title, whereupon the mayor stated the motion and asked for a roll call vote which resulted as follows:

Ordinance No. 173, having received the required number of vvotes, the mayor declared the same to have duly passed and to have been duly adopted.

Ordinance #174-Dedicating certain property as a public street. Ordinance No. 174 was read in full. MOTION by Ernest Christensen that the rules be suspended and an emergency declared and that the ordinance be read the second time by title only. Motion seconded by Councilman Weideman. Motion carried then the ordinance was read the second time by title. MOTION by councilman Weideman that it be read a third time by title and declaring an emergency be placed upon its final passage and that it be in full force and effect from and after its passage. Motion seconded by Henry Kerr. Motion carried. The ordinance was then read the third time by title, whereupon the mayor stated the motion and asked for a roll call vote which resulted as follows:

Ordinance No. 174, having received the required number of votes, the mayor declared the same to have duly passed and to have been duly adopted.

Regular Council Meeting-Oct. 8, 1963, Continued)

Resolution #96-Personnel Policy--The resolution was tabled until the councilmen have additional time to study certain features of said resolution.

LeRoy Weideman reported that he is working on the plans and specifications for the city equipment building and will probably have them completed sufficient for bid purposes within the next few days. The councilmen asked that advertisement for bid call be published and a special council meeting called if necessary in order to expedite consideration of bids and to get the project underway.

In answer to questions regarding the matter of serving warrants and arrests, attorney Balderree explained that city police officers have no jurisdiction out the city limits unless the action involved what is known as "Hot Pursuit", and that warrants could only be served within the corporate limits of the city.

Mayor Dimmick informed the council that all delinquent assessment accounts have now been referred to the City Attorney for collection.

Attorney Balderree reported that the Brookings Plywood Corporation is agreeable to the execution of an understanding that it will either excavate and repair at the corporation's expense or re-locate at the corporation's expense, the district #10 sewer line that has been covered, in the event a break should occur. He stated that he would prepare a form of agreement that would be acceptable to the city in order that both parties may promptly review the same and have it executed.

Pertaining to a suggestion that parking meters, located in front of the Doctor's office be removed and replaced by an emergency parking only sign, Chief of police C. M. Cross stated that emergency vehicles usually have a place to park in the area, at the present time, and that such a change, whereby private vehicles could use the area for "emergency" parking, would increase the policing problem. He recommended that the meters be left as they are.

A petition was presented, asking that the existing street commonly known as Marine Drive, and including the easterly extension thereof, be accepted as a city street. The council asked that the matter be referred to the Planning Commission and the city draftsman for a feasibility study, after property owners in the area have signed the petition.

Superintendent of Public Works, Frank Harrison, expressed his disapproval of the manner in which the Brookings Water Company has been repairing certain city streets after cutting into the same for water line repairs and extensions, stating that in numerous instances, the Co. has not completed the job within the time specified on the permit, that the work has not been done satisfactorily nor fully completed in other instances. He questioned the adequacy of the bond deposit in the maximum anount of \$100.00 per permit, as provided in the ordinance. He explained that he could not approve nor accept the repairs made on Easy Street, noting that it would cost several hundred dollars to put the same back in the condition it was in, prior to the cut.

The council requested that a letter be submitted to the owner of the City Hall building asking that the exterior of the building be painted. They also asked that the signs on the window, be repainted at the city's expense.

Mayor Dimmick asked that a monthly report of court proceedings be submitted to the council at subsequent meetings.

Financial reports were presented, including police and library reports and also schedules of Municipal court fines and parking meter warrants, receivable and written off.

Vouchers payable in the total amount of \$ 4,578.47 (per attached schedule) were submitted for review and approval. MOTION BY LeRoy Weideman that the bills be approved for payment. Seconded by Ernest Christensen. Motion Carried.
