MINUTES OF THE SPECIAL CITY COUNCIL MEETING CITY OF BROOKINGS APRIL 4, 1963

MEETING CALLED TO ORDER AT 8:10 P. M., Mayor Robert O. Dimmick presiding. Councilmen present; Ernest Christensen and Ben Franklin, Jr.

Mayor Dimmick explained that the main purpose of the meeting was to discuss the feasibility of forming a new sewer district (Sewer District #13) and to determine the views of all the property owners within the area in this regard.

IT WAS THE CONCENSUS OF OPINION OF THOSE PRESENT THAT SEWER LINE DEVELOPEMENT, AT THIS TIME WOULD BE AN UNNECESSARY BURDEN IN PROPORTION TO THE
BENEFITS TO BE DERIVED, MOSTLY FROM THE STANDPOINT OF SPARSE HOMES AND
IMPROVEMENTS IN THE AREA. IT WAS ALSO NOTED THAT IN THE EVENT SEWERS ARE
LATER INSTALLED, COVE ROAD SHOULD BE MADE INTO A 50 FOOT STREET IF POSSIBLE.
MR. ELMER BANKUS STATED THAT HE WOULD BE WILLING TO DEED 10 FEET OF HIS
PROPERTY IN ORDER TO ACHIEVE THIS, IF THE OTHER PROPERTY OWNERS WISHED TO
DO THE SAME.

AFTER FURTHER DISCUSSION, MAYOR DIMMICK, SUPPORTING THE VIEWS OF THE COUNCIL AND THOSE PRESENT, STATED THAT NO SEWER DISTRICT WOULD BE FORMED TO IMPROVE THE AREA UNDER REVIEW, UNLESS OR UNTIL THE CITY IS PETITIONED THEREFORE.

CITIZENS PRESENT INDICATED THAT IF REASONABLE DEVELOPEMENT SUBSEQUENTLY OCCURS IN THE AREA, THEY MAY BE INTERESTED AT THAT TIME.

REGARDING REQUEST FOR ENDORSEMENT OF "APPLICATION FOR CLASS B DISPENSER'S LICENSE", SAID APPLICATION SUBMITTED BY LESTER W. WHITMAN OF SALEM, OREGON; AND AFTER REVIEWING THE APPLICATION AND A REPORT FROM THE SALEM POLICE DEPT., THE RECORDER WAS INSTRUCTED TO NOTIFY THE APPLICANT THAT HIS REQUEST HAS BEEN DENIED AT THE PRESENT TIME.

Resolution No. 92. Authorizing Mayor Dimmick to execute documents pertaining to storm damage -- Motion by Ben Franklin, Jr., that resolution No. 92 be adopted. Seconded by Ernie Christensen. Motion Carried.

THE COUNCIL WAS INFORMED THAT THE STATE HIGHWAY DEPT. WILL "RE-DO" THE STRIP-ING OF STREETS LATER THIS SUMMER AT NO ADDITIONAL COST, NOTING THAT THE WORK WAS COMPLETED UNSATISFACTORILY DUE TO THE ADVERSE WEATHER CONDITIONS PREVAILING AT THE TIME IT WAS DONE.

THE RECORDER WAS INSTRUCTED TO WRITE TO THE STATE HIGHWAY DEPARTMENT FOR ADDITIONAL INFORMATION AND TO FURTHER CLARIFY THE CITY'S REQUEST FOR CROSS WALK AND TRAFFIC CONTROL SIGNS.
