MEETING CALLED TO ORDER AT 8:00 P. M., SEPTEMBER 24, 1962; MAYOR, C. F. CAMPBELL  
PRESIDING: COUNCILMEN PRESENT; ERNEST CHRISTENSEN AND BEN FRANKLIN JR. ABSENT:  
ROBERT DIMMICK.

HEARING WAS HELD IN CONNECTION WITH STREET IMPROVEMENT DISTRICT #7. THERE  
WERE NO WRITTEN OR ORAL OBJECTIONS TO SAID PROJECT, RECEIVED PRIOR TO NOR DURING  
THE HEARING.


ORDINANCE NO. 170--AN ORDINANCE CREATING A SPECIAL IMPROVEMENT DISTRICT WITHIN  
THE CITY OF BROOKINGS, OREGON, TO BE KNOWN AS STREET IMPROVEMENT DISTRICT  
No. 7, DESIGNATING THE PROPERTY TO BE SPECIALLY BENEFITED BY SAID STREET IMPROVE-  
MENTS, LEVYING A SPECIAL ASSESSMENT UPON THE PROPERTIES WITHIN SAID DISTRICT,  
PROVIDING FOR THE PAYMENT OF THE COSTS OF SAID IMPROVEMENT AND DECLARING AN  
EMERGENCY, WAS READ THE FIRST TIME IN FULL.

THEREUPON COUNCILMAN CHRISTENSEN MOVED THAT THE RULES BE SUSPENDED AND AN  
EMERGENCY DECLARED AND THAT THE ORDINANCE BE READ THE SECOND TIME BY TITLE  
ONLY. MOTION SECONDED BY COUNCILMAN FRANKLIN. MOTION CARRIED THEN READ THE  
SECOND TIME BY TITLE. MOTION BY COUNCILMAN FRANKLIN THAT IT BE READ A THIRD  
TIME BY TITLE AND DECLARING AN EMERGENCY BE PLACED UPON ITS FINAL PASSAGE AND  
BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE. MOTION SECONDED BY  
ERNEST CHRISTENSEN. MOTION CARRIED. THE ORDINANCE WAS THEN READ THE THIRD  
TIME BY TITLE, WHEREUPON THE MAYOR STATED THE MOTION AND ASKED FOR A ROLL CALL  
VOTE WHICH RESULTED AS FOLLOWS:

NAYES	NONE
ABSENT	ROBERT DIMMICK

ORDINANCE No. 170 HAVING RECEIVED THE REQUIRED NUMBER OF VOTES, THE MAYOR  
DECLARED THE SAME TO HAVE DULY PASSED AND TO HAVE BEEN DULY ADOPTED.
