

CONTINUATION OF REGULAR MEETING OF JANUARY 9, 1962--MAYOR C. F. CAMPBELL CALLED THE MEETING TO ORDER AT 7:35 P. M., JANUARY 11, 1962. COUNCILMEN PRESENT: ERNIE CHRISTENSEN, ROBERT DIMMICK, BEN FRANKLIN JR. OTHERS PRESENT: CITY ATTORNEY, W. W. BALDERREE.

IT WAS EXPLAINED BY THE CITY ATTORNEY THAT THE ADVERTISEMENT WHEREIN THE CITY CALLED FOR BIDS ON GASOLINE, MET THE LEGAL REQUIREMENTS PERTAINING TO GASOLINE BIDS BUT THAT THE BIDS RECEIVED FOR DIESEL AND STOVE OIL WERE NOT LEGALLY ACCEPTABLE, DUE TO THE WORDING OF THE ADVERTISEMENT.

MOTION BY ERNIE CHRISTENSEN THAT THE PORTION OF THE PREVIOUS MOTION, PERTAINING TO ACCEPTANCE OF THE BID ON DIESEL AND STOVE OIL, BE HEREBY RESCINDED AND THAT THE CITY CALL FOR BIDS FOR DIESEL AND STOVE OIL FOR USE IN CITY BUILDINGS AND EQUIPMENT, SAID BIDS TO BE PUBLICLY OPENED AND READ ALOUD AT 8:00 P. M., FEBRUARY 13, 1962. MOTION SECONDED BY ROBERT DIMMICK--MOTION CARRIED.

ROBERT DIMMICK MOVED THAT AT SUCH TIME AS A FIRE AND POLICE DESPATCHER IS HIRED, IN ADDITION TO FREE LIVING QUARTERS, A BASIC SALARY OF \$50.00 PER MONTH BE PAID. SECONDED BY BEN FRANKLIN JR.,. MOTION CARRIED.

ROBERT PATERSON-FOX, CITY DRAFTSMAN, PRESENTED A COST ESTIMATE IN CONNECTION WITH POSSIBLE FUTURE SEWER DISTRICT, SAID ESTIMATE AND PLAT THEREON REFERRING ARE ON FILE AT CITY HALL. MR. PATTERSON WAS AUTHORIZED AND REQUESTED TO PROCEED WITH PRELIMINARY PLANNING IN CONNECTION WITH THE MATTER.

CARL OSTENBERG REGISTERED A COMPLAINT IN CONNECTION WITH A PORTION OF THE STREET NEAR THE CORNER OF CHETCO AVE. AND CITY STREET. MR. ELMER BANKUS STATED THAT HE WOULD CHECK INTO THIS MATTER THE FOLLOWING WEEK TO DETERMINE IF THE CONDITION WAS CAUSED FROM A LEAKING OR BROKEN WATER LINE, AND IF SO, WOULD IMMEDIATELY REPAIR THE SAME.

THE COUNCILMEN DISCUSSED FURTHER THE NEED OF ACQUIRING A NEW 5 OR 6 YARD DUMP TRUCK AS SOON AS POSSIBLE, AND ALSO THE POSSIBILITY OF PURCHASING A SMALL USED TRUCK IF IT CAN BE ACQUIRED AT A REASONABLE PRICE. IT WAS ALSO NOTED THAT THE CITY IS IN NEED OF OTHER EQUIPMENT, INCLUDING A TARPOT AND ROLLER, AS PREVIOUSLY DISCUSSED AT OTHER COUNCIL MEETINGS. COUNCILMEN DIMMICK REQUESTED THAT FRANK HARRISON COME UP WITH SPECIFICATIONS FOR A TRUCK AT THE NEXT REGULAR MEETING.

A LENGTHLY DISCUSSION FOLLOWED REGARDING THE POSSIBLE PURCHASE OF THE PRESENT PRIVATE WATER SYSTEM OR THE FEASIBILITY OF BUILDING A NEW SYSTEM. MR. BANKUS AGAIN STATED THAT HE WAS WILLING TO SELL. HE SAID THAT HIS ENGINEERS WOULD BE MADE AVAILABLE WITHIN A WEEK AND IN HIS OPINION THE EVALUATION COULD BE COMPLETED IN 6 OR 8 WEEKS.

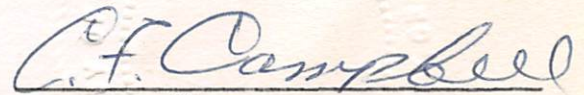
MOTION BY ROBERT DIMMICK THAT A SURVEY OF THE PRIVATE WATER SYSTEM BE MADE BY THE CONSULTING ENGINEER OF THE CITY, WORKING IN CONJUNCTION WITH THE ENGINEER OF THE BROOKINGS WATER COMPANY, SAID SURVEY TO INCLUDE THE ENTIRE SYSTEM FOR THE PURPOSE OF ARRIVING AT A VALUATION ACCEPTABLE TO THE CITY AND TO THE BROOKINGS WATER COMPANY, WITH THE INTENT OF PURCHASING SAID SYSTEM IF ECONOMICALLY FEASIBLE AND IF APPROVED BY THE CITIZENS OF THE COMMUNITY AND FURTHER, THAT THE REPORT ON THE SURVEY BE SUBMITTED TO THE CITY COUNCIL ON OR BEFORE APRIL 10, 1962. MOTION SECONDED BY BEN FRANKLIN JR. ROLL CALL VOTE AS FOLLOWS:
