Meeting called to order at 8:00 P.M.

Sam Hall gave a report on his work on ordinances.

Communications read and disposed of, including recommendations for Mr. Brown for the position of police officer and a letter from the State Highway Commission concerning parking.

The subject of a city engineer was brought up and discussed.

Sam Hall read the ordinances as prepared by him to be voted on by the council.

#1 - Ordinance on adopting ordinances and declaring emergencies.

#2 - Ordinance governing the action of the Council, its officers, etc.

#3 - An ordinance, creating the office of recorder, and setting up his duties.

#4 - An ordinance, creating the position of City Attorney and setting up his duties and powers, and compensation.

#5 - An ordinance creating the position of police officers and defining their duties and powers and compensation.

#6 - An ordinance licensing businesses in Brookings and setting up specific fees for each type of business.

#7 - An ordinance providing for money depository payment of warrants, etc.

#8 - An ordinance creating a municipal court, municipal judge and penalties for violations.

Mr. Means appeared at the meeting to be interviewed for the position of Police, and after considerable discussion it was decided to hire Mr. Brown as Police Chief and Mr. Means will be contacted as to part time employment.

Lesmeister moved we adjourn.

Regular meeting of the Council of the City of Brookings on October 19th., 1951 and minutes of the meeting.

Meeting called to order by Mayor Robert O. Dimmick at 8:00 p.m. with the following Councilmen present, Warren Smith, Pete J. Lesmeister, Fred Fox and Charles Young. The following citizens were present at the meeting Dewey Akers, Orville Dimmick and Mr. Means.

Attorney Samuel A. Hall gave a report on the ordinances that he had prepared.

Communications read and approved, including recommendations for Mr. ~~Bro~~ Brown for the position of Police officer and a letter from the State Highway Commission concerning parking.

The subject of a City Engineer was brought up and discussed.

Attorney Samuel A. Hall read the ordinances as prepared by him to be voted ~~by~~ on by the City Council.

Ordinance No.1.. An ordinance Relating to Procedure For the Passage of Ordinances and Declaring An Emergency.

Ordinance No. 2..An Ordinance Adopting Certain Rules Governing the Proceedings of the Council, Providing for the Appointment of a Mayor Pro Tem, Prescribing the Time and Place of Council Meetings, and Declaring an Emergency. The City of Brookings Does Ordain as Follows:

Ordinance No. 3..An Ordinance Creating the Office of Recorder, Defining the Duties thereof, Requiring a Surety Bond, Providing the Compensation for the Recorder, and Declaring an Emergency.

Ordinance No. 4.. An Ordinance Creating the Office of City Attorney, Prescribing the Qualifications Therefor, Providing the Jurisdiction and Duties Thereof, Providing the Compensation Therefor, and Declaring an Emergency.

Ordinance No. 5.. An Ordinance Creating a Bureau of Police, Providing for the Offices of Commissioner of Police and Chief of Police, Providing for the Duties Thereof, Providing for the Compensation Therefor, Providing the Authority and Jurisdiction of the Commissioner of Police and Declaring An Emergency.

Ordinance No. 6..An Ordinance Regulating and Licensing Certain Businesses, Professions, Pursuits and Occupations in the City of Brookings for Regulatory and Revenue Purposes, Fixing the Fees Therefor, Providing for an Increase or Decrease of the Same, Fixing the Penalty for Violation Thereof. Providing for the Enforcement Thereof, Providing Certain Definitions, Providing for a Savings Clause and Declaring an Emergency.

Ordinance No.7.. An Ordinance Providing For Money Depositories, Providing For Creation of Funds, Providing For Warrants and When Interest Is Payable Thereon, Defining Additional Duties of the City Recorder and Declaring an Emergency.

Ordinance No.8.. An Ordinance Creating A Municipal Court, Creating the Office of Municipal Judge, Prescribing the Jurisdiction of Said Court and Judge, Providing for the Making of Rules of Said Court, Providing for Procedure of Said Court, Providing for Trial Without Jury and Declaring an Emergency.
