Mr. Jim Robinson appeared before the City Council requesting approval of the Council on a Restaurant License. This license permits the public to bring in hard liquor into his place of business and have mixed drinks. Approval must be given by the City Council on his application before the Oregon State Liquor Control Commission will issue a license. Mayor Dimmick stated the Council would want additional time to study his request before taking action.
