

MINUTES OF REGULAR MEETING
OF THE CITY COUNCIL
OF BROOKINGS, OREGON, HELD
FEBRUARY 9, 1960

THE COUNCIL MET IN REGULAR SESSION ON FEBRUARY 9, 1960, AT 8:00 O'CLOCK PM.

PRESENT WERE MAYOR CAMPBELL, COUNCILMEN GOETZ, HANKS, HEIN AND PHETTEPLACE, ATTORNEY BALDERREE, ART LAWN, KEN CURRY, CURLY ANDERSON, EVERETT ECHOLS, FRANK HARRISON, FRANK BLACHLEY, RUSSELL JENKINS, ARTHUR HAWK AND OTHERS.

THE CITY RECORDER OPEN AND BIDS ON MATERIAL AND PIPE FOR SEWER DISTRICT No. 8 WERE READ AS FOLLOWS:

1. MEDFORD CONCRETE CONSTRUCTION COMPANY, INC.
2. JOHNS-MANVILLE
3. DICKSON CONCRETE PIPE COMPANY
4. HILFIKER CONCRETE PIPE COMPANY

MR. HARRISON AND MR. ECHOLS WERE APPOINTED TO TABULATE THE BIDS AND RECOMMEND THE ACCEPTANCE OF ONE AT A LATER DATE.

THE MINUTES OF THE REGULAR MEETING HELD ON JANUARY 12, 1960, AND THE SPECIAL MEETING HELD ON JANUARY 26, 1960, WERE READ AND APPROVED.

A MOTION WAS MADE BY COUNCILMAN PHETTEPLACE AND SECONDED BY COUNCILMAN HEIN THAT THE MAYOR AND RECORDER BE AUTHORIZED TO EXECUTE AN AGREEMENT WITH COOS-CURRY ELECTRIC FOR THE PLACING OF A STREET LIGHT AT ALDER AND MEMORY LANE. MOTION CARRIED UNANIMOUSLY. MAYOR CAMPBELL REPORTED THAT MR. DEMOSS HAD AGREED TO PAY FOR THE STREET LIGHT UNTIL JULY 1960.

MAYOR CAMPBELL REPORTED THAT MR. ERICHSEN HAD BEEN TO BROOKINGS AND THAT THE TREATMENT PLANT WAS WORKING SATISFACTORY TO DATE.

MAYOR CAMPBELL REPORTED THAT NOTHING FURTHER HAD DEVELOPED IN REGARD TO COTTAGE STREET AND THAT NO ACTION WOULD BE TAKEN ON MAKING IT A TRUCK ROUTE AT THIS TIME.

AN ORDINANCE CONTROLLING DOGS WAS AGAIN DISCUSSED. MAYOR CAMPBELL REPORTED HE HAD OBTAINED A SPECIMAN ORDINANCE IN THIS REGARD FOR STUDY BY THE COUNCIL.

COUNCILMAN HEIN REPORTED THAT MR. ERICHSEN IS WORKING ON PLANS FOR A NEW CITY HALL AND SHOULD HAVE PLANS TO PRESENT IN THE NEAR FUTURE.

COUNCILMAN GOETZ REPORTED HE HAD ORDERED MATERIALS ON TAR POTS BUT TO DATE HAD RECEIVED NO FURTHER INFORMATION.

A LIST OF PROPERTY OWNERS THAT HAVE BEEN ASSESSED FOR THE SEWER BUT THAT HAVE NOT CONNECTED TO THE SEWER WAS PRESENTED. THE COUNCIL AUTHORIZED THE RECORDER TO NOTIFY THE PROPERTY OWNERS THAT THEY MUST MAKE CONNECTION TO THE SEWER WITHIN THIRTY DAYS. THE RECORDER WAS ALSO INSTRUCTED TO NOTIFY THE PLUMBERS THAT THEY CANNOT MAKE ANY CONNECTIONS TO THE SEWER WITHOUT HAVING FIRST OBTAINED A PERMIT TO DO SO. BOB FOX WAS ALSO INSTRUCTED TO CONTACT A NUMBER OF PROPERTY OWNERS PERSONALLY TO ASCERTAIN WHETHER OR NOT THEY WERE CONNECTED TO THE SEWER.

A LETTER FROM THE FIRE DEPARTMENT SUMMARIZING THE ACTIVITIES OF THE FIRE DEPARTMENT FOR THE PAST YEAR WAS READ.

COUNCIL MINUTES - FEBRUARY 9, 1960

A LETTER DATED FEBRUARY 8, 1960, FROM EVERETT ECHOLS APPLYING FOR FULL TIME ENGINEERING WORK WAS READ.

MR. ECHOLS REPORTED THAT EUREKA WAS HOLDING A ONE-DAY SEWER PIPE SCHOOL AND REQUESTED THAT BOB FOX AND FRANK HARRISON BE SENT TO THE SCHOOL. THE COUNCIL AGREED WITHOUT MOTION THAT MR. FOX AND MR. HARRISON SHOULD GO TO THIS SCHOOL.

MR. ECHOLS REQUESTED THAT A PERMIT BE OBTAINED FROM THE HIGHWAY DEPARTMENT TO MAKE A CUT IN THE HIGHWAY NEAR MILL BEACH ROAD TO CONNECT THE A & W DRIVE-IN TO THE SEWER.

MR. ECHOLS PRESENTED MAPS ON EASY STREET, PIONEER ROAD AND ARNOLD LANE SHOWING THE CITY OWNERSHIP OF A PORTION OF THESE STREETS. MR. BALDERREE REPORTED THAT HE HAD CHECKED WITH THE TITLE COMPANY ON A TENTATIVE COST OF GETTING A TITLE REPORT ON THESE STREETS BUT TO DATE HE HAD NOT RECEIVED THIS INFORMATION. THE MATTER WAS TABLED UNTIL AN ESTIMATE OF OBTAINING A TITLE REPORT IS RECEIVED.

MR. ECHOLS WAS INSTRUCTED TO MAKE A LEGAL DESCRIPTION OF AN EASEMENT FOR THE SEWER ALONG SEVENTH STREET SO THE PLANNING COMMISSION COULD PROCEED WITH THE OBTAINING OF THE EASEMENT.

A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN GOETZ THAT MR. HARRISON BE SENT TO THE SEWAGE OPERATORS' SCHOOL IN CORVALLIS TO BE HELD DURING THE WEEK OF FEBRUARY 15.

ART LAWN REPORTED THAT HE WOULD COMPLETE PAVING THE INTERSECTIONS AS SOON AS THE WEATHER PERMITS.

CURLY ANDERSON WAS PRESENT TO INQUIRE WHY THE PEOPLE DID NOT VOTE ON A SITE FOR A NEW CITY HALL IF THEY HAD TO VOTE ON THE BUILDING OF IT. MR. BALDERREE INFORMED HIM THAT IT WAS NOT NECESSARY FOR THE PEOPLE TO VOTE ON THE PLACE IF FUNDS WAS AVAILABLE IN THE TREASURY TO PURCHASE A SITE BUT IF BONDS OR A SPECIAL LEVY WAS TO MADE IT WOULD HAVE TO BE PRESENTED TO THE PEOPLE FOR THEIR APPROVAL. HE ALSO INQUIRED IF A TWENTY-FOUR HOUR SURVEILANCE WAS REQUIRED ON PRISONERS. CHIEF CROSS REPORTED THIS WAS NOT NECESSARY IF THE BUILDING WAS FIREPROOF.

KEN CURRY INQUIRED IF CITY EQUIPMENT COULD BE RENTED TO THE PORT COMMISSION. HE WAS INFORMED THAT IT WAS A COMMON PRACTICE FOR ONE PUBLIC TAX BODY TO RENT EQUIPMENT TO ANOTHER PUBLIC TAX BODY. HE ALSO INQUIRED IF CITY EQUIPMENT COULD BE USED FOR LOADING PRIVATELY OWNED VEHICLES. MR. HARRISON REPORTED THAT CITY EQUIPMENT WAS NOT USED IN THIS MANNER ONLY IN CASES OF EMERGENCY.
