## REGULAR COUNCIL MEETING OF THE CITY OF BROOKINGS Oct 8, 1952

Meeting called to order by Mayor Dimmick.

Councilmen present: Fox, Lesmeister, and Young.

Others present: Judge Nelson, Engineer Echols, Mr. Linklater, acting city atty., Fire Chief Nelson, and Recorder Kanick. Also present were Mr. & Mrs. DePhillips, and Mr. Gosnell.

The following bills were read:

Motion was made by Mr. Lesmeister and seconded by Mr. Young that bills so read be approved. Carried.

Mrs. DePhillips called the Council's attention to the windows in the bowling alley. Claims it disturbs her clients and others and that she can get signers to a petition to have this matter corrected. She also said it was her understanding that this building was to be constructed with no windows on the side and that sky-light ventilation and lighting was to be used entirely. The opinion of those present were also that there were to be no windows on the side in question. Mr. Echols said the building had been constructed as far away from the DePhillip property as the lot allowed and thought that Mr. Rogers plans to have ventilation from the roof and has the necessary equipment ordered ready to be installed. Mrs. DePhillips asked for an 11 o'clock closing hour for the bowling alley. The Mayor suggested that the Council and he interview Mr. Rogers and find out what can be done to eliminate excessive noise if any. He promised to report back at next council meeting.

Mr. Linklater, acting city attorney in the absence of Mr. Hall, reported that Mr. McBride of the West Coast Telephone Company had been in to see Mr. Hall and suggested he pay a lump sum of \$250.00 as the telephone company's tax for this year. Acting on Mr. Hall's recommendation, Mr. Linklater presented Ordinance No.32 which repeals Ordinance #15 and declares.an emergency.

Motion was made by Mr. Young and seconded by Mr. Lesmeister that Ord. #32 entitled: AN ORDINANCE REPEALING ORDINANCE # 15, AND PROVIDING FOR A LICENSE FEE FOR REVENUE PURPOSES ON EACH PUBLIC UTILITY FURTANISHING TELEPHONES AND TELEGRAPH SERVICES IN THE CITY OF BROOKINGS, OREGON, PROVIDING PENALTIES FOR THE VIOLATION THEREOF AND DECLARING AN EMERGENCY, BE READ IN FULL ONCE, Twice by title and passed at this meeting of the council. A poll of ovtes carried the motion as follows: Fox, aye, Lesmeister, a ye, and Young, aye. Mr. Smith, absent.

WHEREUPON said Ordinance #32 was read by Mr. Linklater once in full, twice by title and on motion made by Mr. Lesmeister and seconded by Mr. Fox, passed by the following vote: Fox, aye; Lesmeister, aye, and Young, aye. Mr. Smith, absent.

Motion was made by Mr. Young, seconded by Mr. Fox that Ord.# 39 amending Section 20, of Ordinance #10, entitled "AN ORDINANCE REPEALTING SECTION 20, ORDINANCE #10 PROHIBITING DRIVING WHILE UNDER THE THE INFLUENCE OF INTOXICATING LIQUOR OR NARCOTICS AND PROVIDING PENALTIES FOR THE VIOLATION THEREOF AND DECLARING AN EMERGENCY be read in full, once, twice by title and passed at this meeting of the council. Motion carried by the following vote: Fox, aye, Lesmeister, aye; and Young, aye.

WHEREUPON Mr. Linklater read Ord. # in full once, twice by title and on motion by Mr. Fox, seconded by Mr. Lesmeister, passed by the following vote: Fox, aye, Lesmeister, aye; Young, aye. Mr. Smith was absent.

Mr. Linklater presented the telephone company's 20 year franchise to the council for acceptance.

Mr. Linklater also reported progress in the fire district change over to the city fire department. He requested names and addresses of property owners in old fire district, of Mr. Echols, who said it require a trip to Gold Beach asked authorization of expenses, which was approved by council. He said he would go Monday.

Mr. Linklater presented a model ordinance creating a city fire department for the inspection and approval of the council and also a taxicab franchise.

The Mayor asked that the city attorney have an abandoned car ordinance and also one on health reddy for presentation by next council meeting.

A petition was presented showing that property owners adjacent to the Assembly of God revival meeting, had no objections to conducting such services in their vicinity.

Chief Nelson asked if it was necessary to call for bids on fire truck up-keep and was told it wasn't but to distribute the business as impartially as possible.

The Mayor said Miss Burns had advised that Mr. Bankus wishes to have the alley behind certain described property belonging to him re-located back from it's present line. It was pointed out that vacation proceedings were necessary.

Recorder reported on election for councilmen petitions and asked opinion of the council how many ballots to have printed. It was decided to have 600 regular ballots and 100 sample ballots.

It was reported that the culvert on cemetery road needs boxing at each end.

Mr. DePhillips asked if the council would approve his signing the entrance to his drive-way with a "no parking" marker. He also asked if the council had any plans for special policing there. He was given permission to go ahead.

The recorder was authorized to go ahead and draw an interest bearing warrant for the payment of the \$\pmu\_1250.00 loan with the Curry County Bank together with interest due for the six months at 5%. Motion was made by Mr. Fox, seconded by Mr. Young and carried to that effect.

A finanicial report was presented by the recorder.

On motion by Mr. Fox seconded by Mr. Young, meeting adjourned.
