

REGULAR COUNCIL MEETING OF THE CITY OF BROOKINGS  
Nov. 18, 1952

Meeting called to order by Mayor Dimmick.

Councilmen present: Mr. Fox, Mr. Lesmeister, and Mr. Young.

Other Officers present: Mr. Arp, Chief Brown, Atty. Hall, Fire Chief Nelson, Judge Nelson, and Recorder Kanick. Also Mrs. Irma Rice, Mr. Roy Brown, Mr. Brooks and Mrs. Byrnes.

Minutes of the previous meeting read and approved with the stipulation that Mr. Rogers' name be included as present.

Motion was made by Mr. Fox, and seconded by Mr. Young, that the bills were allowed and paid as funds are available. Carried.

The application of Mr. & Mrs. James Robinson for a class R.B. License was presented for the council's approval. Motion was made by Mr. Fox, seconded by Mr. Lesmeister that the council approve the Robinson's class R.B. license. Motion carried.

Mr. Arp reported culvert in and work satisfactorily completed on the general drainage project on Oak, Del Norte and Railroad streets. He also reported that this work had been accomplished at a lesser cost than the \$750.00 he had estimated. He suggested that the City Engineer, Mr. Echols, be instructed to write a description of the property to be deeded to the city by W.W. Wollam located at the intersection of Oak and Railroad.

Mrs. Irma Rice and Mr. Roy Brown were present in the interests of the Chetco Community Library Association. They wished to ascertain whether or not the City would accept a deed to the library property when completed. It was pointed out that ownership by the city would make this property tax exempt but would entail it's upkeep, heating and salaries. However, the council was favorable to the matter but thought it should be referred back to the library board before definite action was taken.

Mr. Brooks was present from Coos-Curry Electric Company to ask that the privilege tax passed recently by the council pertinent to his company, be in effect from November on rather than from January of this year. The council was not receptive to this suggestion and countered with a proposal that the electric company give street lighting in lieu of cash for equal months beginning in October and extending into July of next year. Mr. Brooks promised to present this proposal to his board of directors and report back next meeting.

Mrs. Byrnes, representing Mr. Elmer Bankus presented a map of the proposed alley re-location project, showing changes in the affected area. Mr. Hall gave technical information as to the necessary procedure, resolution and publication notices. Mrs. Byrnes asked that if the council saw fit, to go ahead with hearing and proceedings. There being no objection by council, Mr. Hall presented the following resolution:
