Attorney Hall read from the state law conderning zoning and planning.

Councilman Young reported that for street names at the principal corners of the city that the following would be required: 90 posts, 70 two sided signs and 20 one sided signs.

Mr. Bert Joy who appeared before the council as a resident along Arnold Lane stated that he thought that the property owners along Arnold Lane felt that the roadway of 40 feet should be obtained from the property on both sides of the street--25 feet from the West side and 15 feet from the Eqst side.

Roy Weideman asked for clarification of the requirements on bids for constructioncof the jail. Councilman/moved adjournment, seconded by Young. Council adjourned at 11:30 P. M. to meet again on March 25, 1952.
