MINUTES OF THE REGULAR MEETING OF THE CITY COUNCIL September 14, 1954

Meeting called to order by Mayor Dimmick.

Councilman present: Mr. Lesmeister, Mr. Manley, and Mr. Smith.

O cers present: Mr. Ackley, Mr. Arp, Mr. Cross, Mr. Echols, Judge Nelson and Recorder Kanick. Others present were Messrs. Bankus, Phillips, Allsup, McKenzie, Murphy, Clark, Brigm and Morton.

Minutes of the previous meeting were read and approved.

Mr. Bankus was asked how he was coming along with fire hydrant installations and replied that he was placing them as fast as time and funds permitted. He said one hydrant was now being installed on Redwood and one at 5th st. & Easy. and that 12 had been completely installed to date.

Mr. Bankus took this opportunity to request that he be allowed to open Easy St. to install 26" cast iron water line to replace an old line and that Easy street be closed to traffic during the time necessary to do this work. Mr. Echols and Mr. Arp were instructed to investigate the feasibility of doing this work this late in the Fall.

Discussion on this request disclosed the need to replace this line but that Fall was a poor time to tear up a street, that a plan of construction be made, that a grade be established, a time limit set for the work to be done, and a performance and liability bond be given the city. The matter was taken under advisement for the time being.

A iscussion was held as to the ownership of sewers in the City of Brookings wheld at this time with the Council maintaining that the abutting property owners were the owners and Mr. Bankus holding the opinion that he personally was the owner.

Mr. Phillips representing the V.F.W. asked permission to drill holes in the pavement or sidewalk so that flag-holders could be inserted. He said the V.FW. were planning to furnish the merchants a flag service for the nominal fee of \$10.00 per year and would need this permission to do the necessary installation work.

Motion was made by Mr. Smith, seconded by Mr. Lesmeister that this permission be granted subject to the approval of Street Supt. Mr. Arp. Carried.

Mr. Morton was present in the interests of the Presbyterian Church. He presented a petition asking vacation of Fir Street from Pacific Avenueto Oak Street and a portion of the alley located and abutting on lots 14, 15, 16, 17, 18, 19, and 20 and lots 7,8,9,10,11, 12, and 13 Block 17, Plat No.1, Brookings.

Upon reading of the petition, Mr. Manley recommended that it be referred to the Planning Commission for action as soon as possible.

Mr. Clark of the firm of Clark & Groff, consulting Engineers of Salem gave pertinent information concerning municipal water systems, cost of Gold Beach's proposed new system, cost of filtration plants, and costs of various types of water systems for cities comparable in size to Brookings.

Mr. Echols advised that \$5586.00 had already been paid on the contract bid of \$7999.50 and that the balance unpaid on this in the amount of \$1409.50 was payable now and that additional costs would be ascertained and submitted to the Council for verification and authorized payment. He suggested that the \$1409.50 be approved for payment at this time. The Recorder was authorized to make this payment if funds were available.

Mr. Lesmeister brought up for discussion the need to control parking by all day tavern patron at the parking meters.

Mr smith reported that the Mayor, the Recorder and himself had given the needs of the various city departments thoro study for the purpose of arriving at a new tax base. It was decided that a meeting of the Council with the Citizen's or Budget Committee be held Friday evening at 8 P.M. Sept. 17, at the City Hall. The Recorder to notify members.

Chief Cross reported that school signs were being painted and erected.

Mr. Arp reported that certain of the street Department bills covered long needed underground drainage improvement on Redwood near Oak and at Spruce and Oak.

A petition requesting the widening of a certain road easement, known as Moore Lane was presented by Mr. Arp for these owners. Mr. Arp was instructed to have these property owners prepare deeds to the City so that water mains and general mainsenance might be made eligible to them.

Planning Commission re-appointment:

Mayor Dimmick reported the re-appointment of Kenneth Osborn to the Planning Commission retro-active to Arpil 21st. 1954, inclusive.

The City Treasurer reported canceling cash General Fund Warrant #694 dated Se .9, 1953 issued in favor of Luther Tisdale and lost.
