

Minutes of Regular Meeting of City Council

October 11, 1955

Meeting called to order by Mayor Brimm.

Councilmen Present: Messrs. Yelton, Manley and Campbell

Officers Present : Attorney Ackley, Supt. Reed, Chief Cross, Mae D. Smith

Others Present : Kathryn Mathiason, Amy Davis, Joe Murphy, Charles Echols, Floyd Jenkins and F. M. McKenzie

Minutes of September 27, 1955 meeting were read. One correction, first part of Recommendation #13 from Planning Commission was adopted up to sentence: Turning left at Pacific Street for the Plywood and continuing on Highway with right turns for west of town mills, excepting those trucks having loads for the Brookings Milling Co. which will necessarily use Azalea Park Road to Pioneer Road and thence up Easy Street. This part of the recommendation was tabled for further study.

Street Sweeper:

Mr. McKenzie reported that he and Mr. Martin had looked over the street sweeper and will wait until a representative from the Equipment Co. comes to town and ask his advice.

Mr. Yelton had no report on insurance of Chief Cross's personal car.

Ambulance Report:

Mr. Manley reported he had talked further to Mr. Brown and some action is being taken in the matter. The books have been turned over to A. E. Botzek. The Beta Sigma Phi Sorority is taking the ambulance problem as their year's project. They have placed jars in the various stores and public places for contributions. They have pledged \$50.00 from their treasury. Several organizations have said they will contribute

financially to the cause. Recorder Smith reported twenty-two letters had been sent out to the various organizations asking them to send a representative to a meeting with the City Council, October 17, 1955.

Chief Cross reported he had hired a new Patrolman, Leonard C. Parker on six month trial basis.

Renting of the old bank building was discussed. Rent is \$150.00.

Pilot Building is \$100.00, with utilities. Mr. Fell Campbell to investigate the building as to rent, accommodations, etc. for Engineering Dept. Will report later.

Mayor Brimm asked that the signs to be put up on truck route be placed as soon as possible. Also signs on Fern Avenue.

Mrs. Mathiason who was present made a complaint about their drive and sidewalk. They have not been able to get in or out for six weeks and it has been three months since they could go in or out all the time. The Beresa Inc. will tear up sidewalk and drive and grade, but will not replace sidewalk and drive. Some discussion followed and Mr. Campbell made the following motion: The City replace sidewalk and drive after Beresa had taken up same and graded. Mr. Yelton seconded the motion which was carried.

Mr. Ackley will write a letter of release to the Beresa Inc. on matter.

Mr. Clarence Kruger was present to apply for a malt beverage license. He was referred to the liquor control board.

It was decided by the Council that the City Recorder go to the League of Oregon Cities Convention in Portland with expenses paid.

Postponement of October 25th meeting was discussed on account of League

of Oregon Cities Convention. Motion was made by Mr. Campbell. Seconded by Mr. Manley that the October 25th meeting be adjourned until November 8th. Carried.

Mrs. Grieg on Pioneer Road presented a map of their place and some land they want to donate to the City for a street. Motion by Mr. Yelton and seconded by Mr. Campbell that the Council accept the offer of Mrs. Grieg to donate land to be used for a street. Carried.

Mr. Reed reported the curbs on Del Norte be paid from the revolving fund. The bid, \$1.65 per running foot.

Mr. Ackley recommended a written agreement with the school board on improvements on Pioneer and Easy Streets before any thing is done.

Signs to be put in crosswalks to be painted and placed soon.

Mr. Ackley to draw ordinance on enforcing the law on same.

Mr. Manley introduced Ordinance #78. Motion, Mr. Yelton, second Mr. Campbell that Ordinance #78 be read once by title and in full. Second reading by title, third time by title. Whereby Ordinance #78:

AN ORDINANCE DECLARING THE INTENTION OF THE CITY OF BROOKINGS, OREGON TO ESTABLISH, OPERATE AND MAINTAIN, WITHIN AND WITHOUT THE CORPORATE LIMITS OF THE CITY OF BROOKINGS, OREGON, A SEWAGE DISPOSAL PLANT OR PLANTS, CONVENIENT FOR A COMPLETE SEWER SYSTEM AND DISPOSAL PLANT OR PLANTS; IMPOSING AN EQUITABLE CHARGE, DECLARING CERTAIN ACTS UNLAWFUL AND IMPOSING PENALTIES AND DECLARING AN EMERGENCY.


