

Minutes of the Regular Meeting of the City Council
of the City of Brookings, Oregon
April 10, 1956

Meeting called to order by Mayor Brimm.

Councilmen present: Messrs. Campbell, Manley, Breuer and Yelton.

Others present : Supt. Reed, Judge Nelson, Chief Cross, Messrs.
Echols, Phillips and Dunning.

Minutes of meeting of March 26 read. There was one correction. Where reference was made to the Area in Resolution #13, it should have read Area 2. After this correction was made and noted, minutes stood approved as read.

Mr. Campbell reported that he had written to Mr. Barr concerning plans for the hospital and that Mr. Barr would soon contact the City Council.

The Wrangler's property was discussed. It was reported that the property adjacent to the Wrangler's property bears a much higher price than that quoted to the City Council.

During a discussion about the Kendall property it was revealed ^{purposely} that Mr. and Mrs. Kendall are not in favor of having the proposed ~~disposal~~ plant placed on their property.

Mr. Manley will discuss further the Harbor Community Fire protection.

Bids on the police car were opened and read. Bids from the following were received:

Dunnings Mennings Dempseys Rupleys

They will be discussed later.

Mr. Phillips read some suggested charges for the ambulance which were presented by the Ambulance Committee. The ambulance is to be conveyed to the City in the near future. Mr. Mendenhall, Fire Chief, will attend the next meeting. Mr. Manley will meet with the Fire Chief and volunteer firemen to discuss the proposed program.

Minutes of the Special Meeting of April 3, 1956 of the City Council were read and approved.

City licenses for Crescent Vending machines were again discussed. Motion was made by Mr. Yelton, seconded by Mr. Breuer, that the license be not considered as a wholesale delivery license nor issued at that price, but that a sticker be placed on every machine in the City including the plywood wood mill. Motion carried.

Bills were read. Motion by Mr. Campbell, seconded by Mr. Breuer that the bills be allowed.

Mr. Campbell reported that he had received complaints from Mrs. Gainey and Mrs. Sam Gott about horses invading their property. Since the complaints were verbal and not written and signed, nothing could be done. All complaints must be so presented to the Council before action can be taken to enforce ordinances prohibiting such things. In this particular case there is an ordinance prohibiting the above invasion.

Judge Nelson asked to have the phone which is presently in the room once occupied by the City Recorder in the Fire Hall, moved into his courtroom. Council gave permission to have phone moved.

The new meters are in the City but not the standards as yet. The Council suggested that Chief Cross meet with Dr. Ronninger concerning the designation of a place in front of the Doctor's office as an emergency site.

Ordinance No. 86 -- An Ordinance to Provide for the Issuance and Sale of City of Brookings Bonds in the Sum of Fifty Thousand Dollars (\$50,000.00) for the Purpose of Providing Funds with Which to Acquire, Construct and Equip a Sanitary Sewer System and Facilities in Connection therewith within the City of Brookings providing for the Sale of said Bonds and for the Advertisement and Sale Thereof and Declaring an Emergency.

was introduced and read by Mr. Manley, once by title and in full, secondly by title, and thirdly by title. Motion was made by Mr. Breuer, seconded by Mr. Campbell, that Ordinance No. 86 be adopted on its immediate passage. AYES: Campbell, Manley, Breuer, Yelton, Brimm. Carried.

Letter was read from the Highway Dept. about an agreement between the Highway Dept. and the City of Brookings concerning Pioneer, Pacific and Easy Streets.

Letter was read from the Highway Dept. to the City Council pertaining to paving Highway 101 through the City of Brookings. Mr. Ackley was asked to examine papers sent to the City Council.

A suggestion was made to call for bids on the sewer and this suggestion was read to the Council. Motion was made by Mr. Manley, seconded by Mr. Yelton, that the City advertise for sewer bids for improvement district No. 2. Motion carried.

Letter was read from the Post Office Dept. concerning city delivery.

Letter was read from State Board of Health. The water in the City Hall is contaminated.

Motion was made by Mr. Campbell, seconded by Mr. Yelton, that a check be forwarded to Cornell, Howland, Hays & Merryfield, the engineering firm, for their services to date to the City. Motion carried.

Mr. Manley and Mr. Reed are to see Mr. Bankus and Mr. Owens about cleaning up their properties.
