

Minutes of Regular Meeting of the  
City Council of the City of  
Brookings, Oregon

May 22, 1956

Meeting called to order by Mayor Brimm.

Councilmen present: Messrs. Yelton, Manley, Campbell and Breuer.

Minutes of Special Meeting of May 15th were read and approved.

Mr. Breuer asked about the three fire plugs at the Brookings Plywood Mill. The Council decided to abide by their previous decision to be responsible only from the present date on.

A letter from C. Ed Dempsey was read. It complimented our Chief of Police on the efficiency of his department.

Ordinance No. 90 was read by Mr. Manley.

Ordinance No. 90: AN ORDINANCE REPEALING ORDINANCE NUMBER 86 OF THE CITY OF BROOKINGS, OREGON, AND DECLARING AN EMERGENCY

read once by title and in full, twice by title and third by title.

Motion was made by Mr. Breuer, seconded by Mr. Yelton, that Ordinance No. 90 be considered and placed on its passage at this time by a unanimous consent of all councilmen present. Ayes: Messrs. Manley, Campbell, Breuer, Yelton and Mayor Brimm. Carried.

Ordinance No. 91 was read by Mr. Manley.

Ordinance No. 91: AN ORDINANCE TO PROVIDE FOR THE ISSUANCE AND SALE OF CITY OF BROOKINGS, OREGON BONDS IN THE SUM OF FIFTY THOUSAND (\$50,000.00) DOLLARS FOR THE PURPOSE OF PROVIDING FUNDS WITH WHICH TO ACQUIRE, CONSTRUCT AND EQUIP A SANITARY SEWER SYSTEM AND FACILITIES IN CONNECTION THEREWITH WITHIN THE CORPORATE LIMITS OF SAID CITY OF BROOKINGS: PROVIDING FOR THE SALE OF SAID BONDS AND FOR THE ADVERTISEMENT AND SALE THEREOF, AND DECLARING AN EMERGENCY.

read once by title and in full, twice by title and third by title.

Motion was made by Mr. Breuer, seconded by Mr. Yelton, that this Ordinance 91 be ~~considered~~ <sup>placed on its passage</sup> at this time by a unanimous consent of all councilmen present. Ayes: Messrs. Manley, Campbell, Breuer, Yelton and Mayor Brimm. Carried.

Motion by Mr. Manley, seconded by Mr. Campbell that a notarized affidavit from the newspaper be given to the City Recorder in the City Hall immediately after the last publication of each item published by the paper for the City. Carried.

Clean up week was discussed. The programme is under way. The City will send its truck in to each precinct on specified days to collect the debris.

Site for disposal unit was discussed. The Committee reported the owner of the property was willing to sell the property in which the City is interested for the disposal unit.

Mr. Ackley had talked to Mr. Butler, Mr. Bankus's attorney, about the sale of the present sewer system. Mr. Bankus will give a right, title and interest to the City and post a bond to protect the City.

Mr. Jim Busch and Mr. Glen <sup>Burdwell</sup>, representatives of the Busch-Copenhagen Contractors, were present. A letter was read from the engineering firm of Cornell, Howland, Hayes & Merryfield to the Council. In this letter the engineering firm recommended the Busch-Copenhagen contractors be given the contract as they are the low bidders. Mr. Busch said the contractors would work with the engineers. The contractors will write a letter to the Council assuring the Council they will work with the engineers. Mr. Ackley will write a letter in reply to Busch-Copenhagen granting them the contract for the sewer facilities, providing the sewer bonds are sold.

Motion by Mr. Campbell, seconded by Mr. Manley that the meeting adjourn until June 12th, 1956.
