MINUTES OF REGULAR MEETING

OF THE CITY COUNCIL

OF BROOKINGS, OREGON, HELD

December 10, 1957

Meeting called to order by Mayor Campbell,

Councilmen Present: Messrs, Hanks, Hagen, Hein and Breuer.

Others Present: Attorney Baldereee, Chief Cross, Judge Kirby, Joseph Murphy, Al Phillips, Bill Spencer and Gordon Olson.

The Council considered sealed bids for Series of 1958 City of Brookings Improvement Bonds in the amount of \$18,525.07 as follows:

- 1. The First National Bank of Portland \$4,826.20 Or an effective rate of 4.44708. The rate being \$100.31 for each \$100.00 par value of bonds.
- 2. The United States National Bank of Portland \$4,837.32 or an effective rate of 4.4573. The rate being \$100.25 for each \$100.00 face value.

After the Council had heard the bids read and considered the same, Councilman Hein moved that the low legal bid of the First National Bank be accepted and that the certified check of the United States National Bank be returned. This motion was seconded by Councilman Hagen. Motion carried unanimously.

Minutes of the meetings of November 12, November 19 and November 26 were read and approved.

A letter from the State of Oregon Water Resources Department in regard to the City's incomplete application for water rights on the Chetco River was read. The Council decided to forward a copy of the letter to Engineer Erichsen for his approval.

A letter from R. H. Erichsen in regard to a contract with his firm to furnish engineering services to the City was presented to the council. The contract was given to Attorney Balderree for his approval before acceptance.

Chief Cross reported on the excessive water rate at the jail. He was instructed to have the meter checked to determine the cause of this high rate.

The publicity committee for the bond issue on the disposal plant reported that they had worked out a set of questions and answers to present to the people

RESOLUTION NO. 31 was read. A motion was made by Councilman Hanks and seconded by Councilman Breuer that Resolution No. 31 be accepted. Motion carried unanimously.

ORDINANCE NO. 110, an ordinance calling a special election in the City of Brookings, Curry County, Oregon, to be held on the 7th day of January, 1958, submitting to the legal voters of said City at said special election a proposed charter amendment of the charter of said City of Brookings amending the charter by adding thereto a new and additional chapter to be known as Chapter XI, as provided by Resolution No. 31 as heretofore adopted, and declaring an emergency was read the first time fully and distinctly at length. Thereupon Councilman Breuer moved that the rules be suspended and an emergency declared and that said ordinance be read the second time by title only. This motion was seconded by Councilman Hagen. The Mayor thereupon stated the motion and the vote resulted as follows:

ORDINANCE NO. 111, an ordinance to amend Section 6 of Ordinance No. 6 of the City of Brookings, as amended by Ordinances No. 80 and 103 and declaring an emergency was read the first time fully and distinctly at length. Thereupon Councilman Breuer moved that the rules be suspended and an emergency declared and that said ordinance be read the second time by title only. This motion was seconded by Councilman Hagen. The Mayor thereupon stated the motion and the vote resulted as follows:
