

MINUTES OF REGULAR MEETING

OF THE CITY COUNCIL

OF BROOKINGS, OREGON, HELD

NOVEMBER 12, 1958

THE COUNCIL MET IN REGULAR SESSION NOVEMBER 12, 1958.

PRESENT WERE MAYOR CAMPBELL, COUNCILMEN HEIN, BREUER, GULLEY AND HANKS, JUDGE KIRBY, GORDON GOETZ, M. A. PHETTEPLACE, CURLY ANDERSON, RECORDER HUDDLESTON, ATTORNEY BALDERREE AND OTHERS.

MINUTES OF THE REGULAR MEETING HELD ON OCTOBER 14, 1958, AND THE SPECIAL MEETINGS HELD ON OCTOBER 21, 1958, AND NOVEMBER 7, 1958, WERE READ AND APPROVED.

THE CITY RECORDER OPENED AND THE COUNCIL CONSIDERED BIDS FOR A NEW POLICE CAR AS FOLLOWS:

A MOTION WAS MADE BY COUNCILMAN BREUER AND SECONDED BY COUNCILMAN GULLEY TO ACCEPT THE LOW LEGAL BID OF AKIN MOTOR COMPANY ON A 1959 FORD IN THE AMOUNT OF \$2291.00. MOTION CARRIED.

A LETTER FROM THE STATE HIGHWAY DEPARTMENT DATED OCTOBER 27, 1958, IN REGARD TO THE STATE PAVING PACIFIC AVENUE FROM FERN STREET NORTHEASTERLY TO THE "WYE" WAS READ.

A LETTER FROM THE STATE HIGHWAY DEPARTMENT SIGNED BY W. C. WILLIAMS DATED NOVEMBER 7, 1958, IN REGARD TO RIGHT-OF-WAY ON THE NORTHERLY SIDE OF THE OREGON COST HIGHWAY IN NORTH BROOKINGS WAS READ.

A LETTER FROM THE STATE HIGHWAY DEPARTMENT DATED NOVEMBER 10, 1958, AND SIGNED BY W. C. WILLIAMS IN REGARD TO THE CITY MAKING APPLICATION FOR FUNDS FOR PAVING ANOTHER STREET UNDER THE SPECIAL CITY ALLOTMENT ACT WAS READ. THE CITY RECORDER WAS INSTRUCTED TO REQUEST AN APPLICATION FOR THIS PURPOSE.

A LETTER FROM HOWARD E. WHITE DATED OCTOBER 26, 1958, IN REGARD TO THE EASEMENT FOR THE SEWER LINE IN DISTRICT No. 8 WAS READ. THE COUNCIL DECIDED TO TURN THE MATTER OVER TO THE CITY ENGINEER.

THE PURCHASE OF AN AIR COMPRESSOR WAS CONSIDERED AGAIN. THE CITY RECORDER WAS INSTRUCTED TO CALL FOR BIDS ON AN AIR COMPRESSOR.

CURLY ANDERSON WAS PRESENT TO DISCUSS THE AMBULANCE AND POLICE PROTECTION PROBLEM IN REGARD TO EMERGENCIES. AFTER CONSIDERABLE DISCUSSION BY THE COUNCIL, IT WAS DECIDED THAT STICKERS SHOULD BE PRINTED AND ATTACHED TO THE FRONT OF THE TELEPHONE BOOKS THROUGHOUT THE CITY. A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN BREUER THAT STICKERS BE PRINTED TO BE ATTACHED TO THE TELEPHONE BOOKS. MOTION CARRIED.

RESOLUTION NO. 39 IN REGARD TO UNPAID IMPROVEMENT LIENS FOR CONSTRUCTION OF SEWER LINES WAS READ. A MOTION WAS MADE BY COUNCILMAN HANKS AND SECONDED BY COUNCILMAN BREUER THAT RESOLUTION No. 39 BE ADOPTED. MOTION CARRIED UNANIMOUSLY.

ORDINANCE NO. 122, AN ORDINANCE AMENDING SECTIONS 3 AND 4 OF ORDINANCE No. 118 PASSED SEPTEMBER 9, 1958, TO PROVIDE THE FORM OF THE BONDS TO BE ISSUED AND DECLARING AN EMERGENCY WAS READ THE FIRST TIME FULLY AND DISTINCTLY AT LENGTH. THEREUPON COUNCILMAN HEIN MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND THAT SAID ORDINANCE BE READ THE SECOND TIME BY TITLE ONLY. THIS MOTION WAS SECONDED BY COUNCILMAN HANKS. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

"AYES": COUNCILMEN HEIN, BREUER, GULLEY AND HANKS AND MAYOR CAMPBELL.

"NAYS": NONE

"ABSENT": NONE

THE MAYOR THEN DECLARED THAT SAID MOTION HAD DULY CARRIED AND DIRECTED THAT ORDINANCE No. 122 BE READ THE SECOND TIME BY TITLE ONLY. SAID ORDINANCE WAS THEREUPON READ THE SECOND TIME BY TITLE ONLY.

THEREUPON COUNCILMAN BREUER MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND SAID ORDINANCE BE NOW PASSED TO ITS THIRD READING BY TITLE ONLY AND PLACED UPON ITS FINAL PASSAGE AND BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE. SAID MOTION WAS SECONDED BY COUNCILMAN GULLEY. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

"AYES": COUNCILMEN HEIN, BREUER, GULLEY AND HANKS AND MAYOR CAMPBELL.

"NAYS": NONE

"ABSENT": NONE

THE MAYOR THEREUPON STATED THE MOTION HAD DULY CARRIED AND DIRECTED THAT ORDINANCE No. 122 BE READ THE THIRD TIME BY TITLE ONLY. SAID ORDINANCE WAS THEN READ THE THIRD TIME BY TITLE ONLY. THEREUPON COUNCILMAN HEIN MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND SAID ORDINANCE BE ADOPTED. SAID MOTION WAS SECONDED BY COUNCILMAN HANKS. THE MAYOR ORDERED THAT THE ROLL BE CALLED AND THEREUPON A ROLL CALL UPON THE FINAL PASSAGE AND THE ADOPTION OF SAID ORDINANCE WAS HAD AND THE VOTE RESULTED AS FOLLOWS:

"AYES": COUNCILMEN HEIN, BREUER, GULLEY AND HANKS AND MAYOR CAMPBELL.

"NAYS": NONE

"ABSENT": NONE

SAID ORDINANCE No. 122 HAVING RECEIVED THE REQUIRED NUMBER OF VOTES, THE MAYOR DECLARED THE SAME TO HAVE BEEN DULY PASSED AND TO HAVE BEEN DULY ADOPTED.
