

MINUTES OF REGULAR MEETING
OF THE CITY COUNCIL
OF BROOKINGS, OREGON, HELD
SEPTEMBER 9, 1958

THE COUNCIL MET IN REGULAR SESSION SEPTEMBER 9, 1958, AT 8 O'CLOCK P.M.

PRESENT WERE MAYOR CAMPBELL, COUNCILMEN BREUER, HEIN AND HANKS, ATTORNEY BALDERREE, CHIEF CROSS, RECORDER HUDDLESTON, BILL SPENCER, MR. ETTINGER, EMMETT GULLEY, LOUISE CLARK, CONNIE BORDWELL, VERNON SHOMSHAK, ART BOLLINGER AND OTHERS.

A LETTER OF RESIGNATION SIGNED BY JACK HAGEN AND EFFECTIVE SEPTEMBER 2, 1958, WAS READ. A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN HANKS THAT MR. HAGEN'S RESIGNATION AS A MEMBER OF THE CITY COUNCIL BE ACCEPTED. A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN HANKS THAT MR. EMMETT GULLEY BE APPOINTED TO THE VACANCY IN THE CITY COUNCIL. MOTION CARRIED. JUDGE KIRBY ADMINISTERED THE OATH OF OFFICE AND MR. GULLEY IMMEDIATELY TOOK HIS PLACE WITH THE COUNCIL.

BIDS ON MATERIALS FOR AN INTERCEPTOR SEWER AND OUTFALL SEWER WERE OPENED. AFTER TABULATION AND RECOMMENDATION BY THE ENGINEER A MOTION WAS MADE BY COUNCILMAN BREUER AND SECONDED BY COUNCILMAN HEIN TO ACCEPT THE BID OF JOHNS-MANVILLE IN THE AMOUNT OF \$9,875.40 FOR 18" CLASS 2400 ASBESTOS CEMENT SEWER PIPE WITH RING-TITE COUPLINGS, RINGS AND LUBRICANT, THE BID FROM DICKSON CONCRETE PIPE COMPANY IN THE AMOUNT OF \$990.85 FOR MANHOLE COVERS AND RINGS, THE BID FROM ARMCO DRAINAGE AND METAL PRODUCTS, INC. IN THE AMOUNT OF \$916.42 FOR 18" CORRUGATED PIPE AND FITTINGS, THE BID FROM VALLEY IRON AND STEEL COMPANY IN THE AMOUNT OF \$414.00 FOR 24" CAST IRON MANHOLE FRAME AND COVER, AND THE BID FROM ROGERS AND KUNI IN THE AMOUNT OF \$1976.00 FOR 30" CONCRETE PIPE. MOTION CARRIED.

THE MEETING WAS THEN OPENED FOR THE HEARING ON SANITARY SEWER DISTRICT No. 8. LETTERS WERE READ PROTESTING THE PROPOSED RATE FOR THE SEWER IN SEWER DISTRICT No. 8. THE LETTERS WERE SIGNED BY NICK BAUMGARTNER, FRED BAUMGARTNER, CHARLES ECHOLS, H. J. HAY, CHARLES STANHURST, C. A. MACKENZIE AND NANNIE GILLIAM. VERBAL PROTESTS WERE ALSO MADE FROM CHARLES STANHURST, FRED BAUMGARTNER, JAMES HAY, BOB STANHURST, MR. CARLILE, MR. ALLISON AND MR. MACKENZIE. AFTER THE WRITTEN OBJECTIONS WERE CONSIDERED AND THE ORAL OBJECTIONS HEARD THE HEARING WAS CLOSED AND THE COUNCIL THEN TOOK THE OBJECTIONS UNDER CONSIDERATION AND DEFERRED ACTION UNTIL A PHYSICAL CHECK OF THE AREA COULD BE MADE AND FURTHER REPORT RECEIVED FROM THE ENGINEERING STAFF.

LETTERS FROM HARRY LOCKLAND AND W. G. HOWGLAND PROTESTING THE PAVING PROPOSED IN THE AIRPORT TRACT WERE READ.

A LETTER FROM THE STATE SANITARY AUTHORITY DATED AUGUST 18, 1958, IN REGARD TO DENIAL OF THE THE CITY'S APPLICATION FOR FEDERAL GRANT WAS READ.

MR. ACKLEY DISCUSSED AT LENGTH A PROPOSITION FOR PAVING ALL OF THE CITY STREETS.

ATTORNEY BALDERREE REPORTED THAT HE HAD CHECKED THE O & C FOREST SERVICE FUNDS PARTIALLY AND WOULD CHECK THE MATTER FURTHER.

ART BOLLINGER REQUESTED THAT THE BRUSH NEAR THE GRADE SCHOOL BE REMOVED.

A LETTER FROM THE BROOKINGS LAND AND TOWNSITE DATED AUGUST 20, 1958, IN REGARD TO THE ROCK CRUSHER BEING INSTALLED NEAR THE MOUTH OF THE RIVER WAS READ. THE COUNCIL REQUESTED THE MAYOR TO CONTACT THE PLANNING COMMISSION TO CHECK THE OPERATION AND REPORT BACK TO THE CITY COUNCIL.

RECOMMENDATION No. 53 FROM THE PLANNING COMMISSION IN REGARD TO ESTABLISHING NO LOADING ZONES IN ALLEYS WAS READ. A MOTION WAS MADE BY COUNCILMAN BREUER AND SECONDED BY COUNCILMAN HANKS TO ACCEPT RECOMMENDATION No. 53 FROM THE PLANNING COMMISSION. MOTION CARRIED.

ORDINANCE No. 117 WAS READ THE SECOND TIME FULLY AND DISTINCTLY AT LENGTH. THEREUPON COUNCILMAN HEIN MOVED THAT ORDINANCE No. 117 BE ADOPTED. SAID MOTION WAS SECONDED BY COUNCILMAN BREUER. THE MAYOR ORDERED THAT THE ROLL BE CALLED AND THEREUPON A ROLL CALL UPON THE ADOPTION OF SAID ORDINANCE WAS HAD AND THE VOTE RESULTED AS FOLLOWS:

"AYES": COUNCILMEN HANKS, HEIN, BREUER AND GULLEY AND MAYOR CAMPBELL.

"NAYS": NONE

"ABSENT" NONE

SAID ORDINANCE HAVING RECEIVED THE REQUIRED NUMBER OF VOTES, THE MAYOR DECLARED THE SAME TO HAVE BEEN DULY ADOPTED.

THE MAYOR REPORTED THAT MR. MACKENZIE HAD GIVEN A FIFTEEN FOOT EASEMENT ACROSS HIS PROPERTY TO THE KLISE PROPERTY FOR THE SEWER LINE. THE CITY CREW WAS INSTRUCTED TO INSTALL THE LINE AS SOON AS POSSIBLE.

SIDNEY KELLEY WAS PRESENT TO DISCUSS THE PARKING METERS. THE COUNCIL GAVE HIM PERMISSION TO REPAIR THE METERS AT A COST OF \$1.00 FOR THE CASE, \$1.00 FOR THE TIMER AND \$3.00 FOR THE BALANCE OF THE METER.

A QUITCLAIM DEED WAS PRESENTED TO THE COUNCIL TO BE EXECUTED BY THE CITY DEEDING PROPERTY ALONG THE HIGHWAY IN NORTH BROOKINGS TO THE STATE HIGHWAY DEPARTMENT. THE COUNCIL DECIDED TO TAKE NO ACTION ON THE DEED UNTIL THE NEXT COUNCIL MEETING.

THERE WAS CONSIDERABLE DISCUSSION ON A WATER LINE FOR THE NEW SCHOOL. THE COUNCIL DECIDED TO HAVE THE ENGINEER MAKE A SURVEY OF THE AREA AND REPORT TO THE COUNCIL AT THE NEXT COUNCIL MEETING.

CHIEF CROSS DISCUSSED THE PROBLEM OF DOGS. THE COUNCIL AUTHORIZED HIM TO HIRE A DOG CATCHER TO BE PAID FROM FEES RETURNED TO THE CITY BY THE COUNTY FOR DOG LICENSE COLLECTIONS.

A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN BREUER TO AUTHORIZE PAYMENT OF THE BILLS AS READ. MOTION CARRIED.

ROBERT PATERSON-FOX REPORTED THAT MUSSER STREET SHOULD BE INCLUDED IN THE PAYING DISTRICT IN THE AIRPORT TRACT. THE COUNCIL AUTHORIZED HIM TO INCLUDE THIS STREET IN THE DISTRICT.

ORDINANCE No. 118, AN ORDINANCE AUTHORIZING THE ISSUANCE AND SALE OF CITY OF BROOKINGS BONDS IN THE SUM OF \$150,000.00 AND PROVIDING FOR THE ADVERTISEMENT AND SALE OF BONDS AND DECLARING AN EMERGENCY WAS READ THE FIRST TIME FULLY AND DISTINCTLY AT LENGTH. THEREUPON COUNCILMAN BREUER MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND THAT SAID ORDINANCE BE READ THE SECOND TIME BY TITLE ONLY. THIS MOTION WAS SECONDED BY COUNCILMAN HANKS. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

"AYES": COUNCILMEN HANKS, HEIN, BREUER AND GULLEY AND MAYOR CAMPBELL.

"NAYS": NONE

"ABSENT": NONE

THE MAYOR THEN DECLARED THAT SAID MOTION HAD DULY CARRIED AND DIRECTED THAT ORDINANCE No. 118 BE READ THE SECOND TIME BY TITLE ONLY. SAID ORDINANCE WAS THEREUPON READ THE SECOND TIME BY TITLE ONLY.

THEREUPON COUNCILMAN HEIN MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND SAID ORDINANCE BE NOW PASSED TO ITS THIRD READING BY TITLE ONLY AND PLACED UPON ITS FINAL PASSAGE AND BE IN FULL FORCE AND EFFECT FROM, AND AFTER ITS PASSAGE. SAID MOTION WAS SECONDED BY COUNCILMAN BREUER. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

"AYES": COUNCILMEN HANKS, HEIN, BREUER AND GULLEY AND MAYOR CAMPBELL.

"NAYS": NONE

"ABSENT": NONE

THE MAYOR THEREUPON STATED THE MOTION HAD DULY CARRIED AND DIRECTED THAT ORDINANCE No. 118 BE READ THE THIRD TIME BY TITLE ONLY. SAID ORDINANCE WAS THEN READ THE THIRD TIME BY TITLE ONLY. THEREUPON COUNCILMAN HANKS MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND SAID ORDINANCE BE ADOPTED. SAID MOTION WAS SECONDED BY COUNCILMAN HEIN. THE MAYOR ORDERED THAT THE ROLL BE CALLED AND THEREUPON A ROLL CALL UPON THE FINAL PASSAGE AND THE ADOPTION OF SAID ORDINANCE WAS HAD AND THE VOTE RESULTED AS FOLLOWS:

"AYES": COUNCILMEN HANKS, HEIN, BREUER AND GULLEY AND MAYOR CAMPBELL.

"NAYS": NONE

"ABSENT": NONE

SAID ORDINANCE No. 118 HAVING RECEIVED THE REQUIRED NUMBER OF VOTES, THE MAYOR DECLARED THE SAME TO HAVE BEEN DULY PASSED AND TO HAVE BEEN DULY ADOPTED.

AN ORDINANCE VACATING A PORTION OF SEVENTH STREET IN THE CITY OF BROOKINGS, OREGON, WAS READ THE FIRST TIME FULLY AND DISTINCTLY AT LENGTH.

A MOTION WAS MADE BY COUNCILMAN GULLEY AND SECONDED BY COUNCILMAN HANKS TO ADJOURN UNTIL TUESDAY, SEPTEMBER 16, 1958, AT 8 O'CLOCK P.M.
