

MINUTES OF REGULAR MEETING  
OF THE CITY COUNCIL  
OF BROOKINGS, OREGON, HELD  
NOVEMBER 10, 1959

THE COUNCIL MET IN REGULAR SESSION ON NOVEMBER 10, 1959, AT 8 O'CLOCK P.M.

PRESENT WERE MAYOR CAMPBELL, COUNCILMEN HEIN, GOETZ, HANKS AND PHETTEPLACE, ROBERT ANDERSON, H. E. ECHOLS, BUD CROSS, BILL SPENCER, JAMES KIRBY, BERNICE HUDDLESTON, ATTORNEY BALDEREE AND OTHERS.

THE CITY RECORDER OPENED AND THE COUNCIL CONSIDERED THE FOLLOWING BID FOR CITY OF BROOKINGS IMPROVEMENT BONDS, SERIES OF 1959 IN THE AMOUNT OF \$48,073.50:

U. S. NATIONAL BANK INTEREST PAYABLE AT  $4\frac{1}{2}\%$  ON BONDS MATURING FROM 1960 TO 1966 AND INTEREST PAYABLE AT  $4\frac{1}{4}\%$  ON BONDS MATURING FROM 1967 TO 1969 INCLUSIVE. THE NET INTEREST COST BEING \$11,848.12 OR AN EFFECTIVE INTEREST RATE OF 4.3547.

THERE BEING NO OTHER BIDS SUBMITTED, A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN GOETZ THAT THE BID OF THE UNITED STATES NATIONAL BANK FOR A NET INTEREST COST OF \$11,848.12 OR AN EFFECTIVE INTEREST RATE OF 4.3547 BE ACCEPTED. MOTION CARRIED UNANIMOUSLY.

THE MINUTES OF THE REGULAR MEETING HELD ON OCTOBER 13, 1959, WERE READ AND APPROVED.

A REQUEST FROM MR. SCHROEDER TO A SIXTY DAY EXTENSION ON THE DISPOSAL PLANT CONTRACT WAS CONSIDERED. A MOTION WAS MADE BY COUNCILMAN PHETTEPLACE AND SECONDED BY COUNCILMAN HEIN AN EXTENSION OF THIRTY (30) DAYS GRANTED THE SCHROEDER PLUMBING AND HEATING ON THE FUNCTIONING EQUIPMENT AND AN EXTENSION OF SIXTY DAYS BE GRANTED ON THE NON-FUNCTIONING EQUIPMENT AND WORK. MOTION CARRIED UNANIMOUSLY.

JIM SILKWOOD, A REPRESENTATIVE FROM RADIO STATION KDOV IN MEDFORD WAS PRESENT TO REQUEST THAT THE COUNCIL GIVE WRITTEN CONSENT TO THE STATION GIVING APPROVAL FOR A CHANGE IN FREQUENCY THAT WOULD GIVE COVERAGE TO BROOKINGS. THE RECORDER WAS INSTRUCTED TO WRITE A LETTER TO THE STATION GIVING APPROVAL FOR THIS CHANGE.

PAUL FAUERSO PRESENTED A PETITION FOR THE VACATION OF A TEN FOOT ALLEY EXTENDING FROM CHETCO AVENUE TO COTTAGE STREET BOUNDED ON THE EASTERLY SIDE BY LOTS 8 THROUGH 18 OF BLOCK 3 AND BOUNDED ON THE WESTERLY SIDE BY LOTS 6, 7 AND 9 OF BLOCK 3. THE COUNCIL INFORMED HIM THAT THE PETITION WOULD HAVE TO BE PRESENTED TO THE PLANNING COMMISSION.

A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN PHETTEPLACE THAT THE RECORDER BE AUTHORIZED TO CANCEL THIRTY FEET OF THE PAVING ASSESSMENT ON THE J. T. JACOBS PROPERTY IN PAVING DISTRICT NO. 6. MOTION CARRIED UNANIMOUSLY.

AN ACCOUNT RECEIVABLE IN THE TOTAL AMOUNT OF \$5,869.74 PAYABLE BY ELMER BANKUS WAS DISCUSSED. MR. BALDERRE WAS INSTRUCTED TO WRITE A LETTER TO MR. BANKUS REQUESTING PAYMENT OF THIS ITEM.

MAYOR CAMPBELL INFORMED THE COUNCIL THAT HAROLD CUMMINGS WANTED TO ESTABLISH A BUS SERVICE IN BROOKINGS AND SURROUNDING VICINITY AND REQUESTED THE PERMISSION OF THE COUNCIL FOR THIS BUSINESS. THE COUNCIL REQUESTED THAT MR. CUMMINGS WORK OUT A SCHEDULE AND PRESENT IT TO THE COUNCIL BEFORE ANY CONSIDERATION CAN BE GIVEN TO THE MATTER.

A TRUST FUND IN THE AMOUNT OF \$75.00 FROM MR. BANKUS FOR REPAIR OF THE STREETS WAS DISCUSSED. IT WAS THE OPINION OF THE COUNCIL THAT THE CITY HAD TO REPAIR A NUMBER OF CUTS IN THE STREET MADE BY MR. BANKUS, THEREFORE, A MOTION WAS MADE BY COUNCILMAN GOETZ AND SECONDED BY COUNCILMAN PHETTEPLACE THAT THE RECORDER BE AUTHORIZED TO TRANSFER THE \$75.00 TRUST ACCOUNT TO THE GENERAL FUND FOR GENERAL EXPENDITURES. MOTION CARRIED UNANIMOUSLY.

MR. SPENCER REPORTED THAT THE EASEMENT FOR A SEWER LINE IN SEWER DISTRICT No. 8 HAD NOT BEEN OBTAINED FROM MR. HOWARD WHITE. MR. SPENCER WAS INSTRUCTED TO CONTACT MR. WHITE AGAIN TO OBTAIN THIS EASEMENT AND ALSO AUTHORIZED HIM TO OFFER A LATERAL IN EXCHANGE FOR THE EASEMENT.

PARKING METERS WERE AGAIN DISCUSSED. THE CHIEF OF POLICE WAS INSTRUCTED TO CONTACT THE AGENT OF DUNCAN-MILLER PARKING METER COMPANY AND SEE WHETHER WE COULD PURCHASE MORE METERS FOR THE SAME PAYMENT EACH MONTH AND PAY ONE-HALF OF THE REVENUE AFTER JULY 1.

A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN PHETTEPLACE THAT THE RECORDER BE AUTHORIZED TO CALL FOR BIDS ON A NEW POLICE CAR WITH SPECIFICATIONS AS OUTLINED BY THE CHIEF OF POLICE.

THE PROBLEM OF STRAY DOGS WAS DISCUSSED. THE MAYOR AGREED TO CONTACT THE COUNTY IN REGARD TO ESTABLISHING A COUNTY DOG POUND.

THE BLIND CORNER AT HASSETT STREET AND PIONEER ROAD WAS DISCUSSED.

A MOTION WAS MADE BY COUNCILMAN GOETZ AND SECONDED BY COUNCILMAN PHETTEPLACE THAT MR. ERICHSEN BE GIVEN AUTHORIZATION TO START ENGINEERING WORK FOR A SEWER DISTRICT FROM THE PUMP STATION TO RANSOM STREET.

MR. ECHOLS AND MR. HEIN REPORTED ON PROBLEMS DISCUSSED AT THE LEAGUE OF OREGON CITIES CONVENTION.
