

MINUTES OF REGULAR MEETING
OF THE CITY COUNCIL
HELD IN BROOKINGS, OREGON
ON APRIL 14, 1959

THE COUNCIL MET IN REGULAR SESSION ON APRIL 14, 1959, AT 8:00 P.M.

PRESENT WERE MAYOR CAMPBELL, COUNCILMEN HEIN, GOETZ, HANKS, PHETTEPLACE, ATTORNEY BALDEREE, JUDGE KIRBY, CHIEF CROSS, RECORDER HUDDLESTON, ROBERT KERR, LLOYD BUNNELL AND OTHERS.

MINUTES OF THE MEETING HELD ON MARCH 10, 1959, AND THE SPECIAL MEETING HELD ON APRIL 2, 1959, WERE READ AND APPROVED.

THE UNSAFE BUILDING OWNED BY THE BROOKINGS BIBLE CHURCH WAS AGAIN DISCUSSED. THE RECORDER WAS INSTRUCTED TO AGAIN CONTACT THE CHURCH TO TEAR THE BUILDING DOWN.

A LETTER DATED APRIL 14, 1959, FROM SIDNEY KELLEY IN REGARD TO PARKING METER REPAIR WAS READ. AFTER SOME CONSIDERATION THE COUNCIL DECIDED TO DISCONTINUE THE SERVICES OF A PARKING METER MAINTENANCE MAN. THE RECORDER WAS INSTRUCTED TO NOTIFY MR. KELLEY ACCORDINGLY. THE COUNCIL WAS OF THE OPINION THAT MR. KELLEY HAD BEEN PAID IN FULL FOR THE SERVICES RENDERED TO DATE.

LLOYD BUNNELL WAS PRESENT TO DISCUSS THE SEWER ASSESSMENT ON TAX LOT 55B AND INFORMED THE COUNCIL THAT THE LOT WAS A SMALL PORTION OF A CANYON AND COULD NEVER BE USED AS A BUILDING SITE, THEREFORE, HE SHOULDN'T BE ASSESSED FOR THE LOT. THE COUNCIL INSTRUCTED HIM TO DISCUSS THE MATTER WITH THE CITY ENGINEER, MR. ERICHSEN.

THE APPLICATION FOR A BUILDING PERMIT FOR J. W. WELCH WAS DISCUSSED. COUNCILMAN HANKS AND IVAN SMITH, THE BUILDING INSPECTOR WAS INSTRUCTED TO MEET WITH MR. WELCH ON THURSDAY, APRIL 16, 1959, TO MAKE A RULING ON THE APPLICATION.

REPRESENTATIVES OF THE HARBOR RURAL FIRE PROTECTION DISTRICT AND THE FIRE CHIEF OF THE BROOKINGS FIRE DEPARTMENT WERE PRESENT TO DISCUSS A MUTUAL AID AGREEMENT WHICH WOULD LOWER THE ^{FIRE}INSURANCE RATING CLASS ^{AND} PROVIDE ADDITIONAL FIRE PROTECTION FOR THE AREA. A MOTION WAS MADE BY COUNCILMAN GOETZ AND SECONDED BY COUNCILMAN PHETTEPLACE THAT AUTHORIZATION BE GIVEN THE BROOKINGS FIRE DEPARTMENT TO ENTER INTO A MUTUAL AID AGREEMENT WITH THE HARBOR RURAL FIRE PROTECTION DISTRICT. MOTION CARRIED.

CHIEF CROSS REQUESTED THE COUNCIL TO REVOKE THE PERMISSION GIVEN TO THE SCHOOL FOR DIAGONAL PARKING ALONG PIONEER ROAD EFFECTIVE THE BEGINNING OF THE NEXT TERM. THE RECORDER WAS INSTRUCTED TO NOTIFY THE SCHOOL ACCORDINLY.

BILL SPENCER WAS INSTRUCTED CONTACT THE LIBRARY AND MAKE ARRANGEMENTS TO HELP WITH THE LANDSCAPING PROJECT.

THE NEED OF A STOP SIGN AT THE INTERSECTION OF NORTH BANK ROAD AND AZALEA PARK ROAD WAS DISCUSSED. A MOTION WAS MADE BY COUNCILMAN PHETTEPLACE AND SECONDED BY COUNCILMAN HANKS THAT CHIEF CROSS BE GIVEN AUTHORIZATION TO PLACE A STOP SIGN ON THE NORTH BANK ROAD WHERE IT MEETS WITH AZALEA PARK ROAD. MOTION CARRIED.

IVAN SMITH DISCUSSED A PROPOSED CARPORT TO BE BUILT BY MR. HOLT ON CHETCO AVENUE.
