

MINUTES OF REGULAR MEETING
OF THE CITY COUNCIL
HELD ON JULY 14, 1959, IN
BROOKINGS, OREGON

THE COUNCIL MET IN REGULAR SESSION ON JULY 14, 1959, AT 8:00 O'CLOCK P.M.

PRESENT WERE MAYOR CAMPBELL, COUNCILMEN HEIN, GOETZ, PHETTEPLACE, HANKS, ATTORNEY BALDERREE, RECORDER HUDDLESTON, CHIEF CROSS, EVERETT ECHOLS, MR. GULLEY, ROBERT KERR, DARREL ALLSUP, BILL SPENCER AND OTHERS.

THE MINUTES OF THE REGULAR MEETING HELD ON JUNE 9, 1959, AND THE SPECIAL MEETINGS HELD ON JUNE 16, 1959 AND JUNE 29, 1959, WERE READ AND APPROVED.

A PETITION SIGNED BY TWENTY RESIDENTS AND PROPERTY OWNERS IN THE AREA OF A VACANT LOT ADJACENT TO 323 DEL NORTE LANE REQUESTING THE COUNCIL TO TAKE ACTION TO HAVE A LOT CLEANED OF DRY GRASS WAS PRESENTED. THE MATTER WAS TABLED UNTIL A LATER DATE WHEN THE COUNCIL HAD AUTHORITY BY ORDINANCE TO TAKE ACTION IN THIS TYPE OF FIRE HAZARD.

MR. GULLEY WAS PRESENT TO DISCUSS THE INADEQUATE POST OFFICE FACILITIES AND REQUESTED THAT THE COUNCIL TAKE ACTION THROUGH THE PROPER CHANNELS TO PROVIDE TEMPORARY AND PERMANENT RELIEF. A MOTION WAS MADE BY COUNCILMAN PHETTEPLACE AND SECONDED BY COUNCILMAN HEIN THAT THE COUNCIL COOPERATE WITH THE CHAMBER OF COMMERCE IN OBTAINING TEMPORARY AND PERMANENT RELIEF IN THE POSTAL PROBLEM. MOTION CARRIED UNANIMOUSLY. THE COUNCIL ALSO INSTRUCTED THE CHIEF OF POLICE TO INSTALL METERS ALONG THE POST OFFICE ON CENTER STREET TO HELP RELIEVE THE TRAFFIC PROBLEM.

RECOMMENDATION No. 57 FROM THE PLANNING COMMISSION IN REGARD TO THE CLOSURE OF FIFTH STREET WAS READ. A LETTER FROM JOHN EBINGER IN REGARD TO FIFTH STREET WAS READ. A MOTION WAS MADE BY COUNCILMAN GOETZ AND SECONDED BY COUNCILMAN HEIN THAT THE MAYOR CONTACT MR. EBINGER AND WORK OUT AN AGREEMENT ON FIFTH STREET TO BE PRESENTED AT THE NEXT REGULAR COUNCIL MEETING. MOTION CARRIED.

ROBERT KERR, FIRE CHIEF, DISCUSSED A RADIO SYSTEM FOR THE FIRE DEPARTMENT.

THE TRAFFIC HAZARD AT THE BANK PARKING LOT WAS DISCUSSED. A MOTION WAS MADE BY COUNCILMAN HEIN AND SECONDED BY COUNCILMAN GOETZ THAT THE CITY RECORDER WRITE A LETTER TO THE UNITED STATES NATIONAL BANK REQUESTING THEM TO OPEN UP THE BACK OF THEIR PARKING LOT TO PROVIDE AN EXIT FOR CARS IN THE PARKING LOT. MOTION CARRIED.

ORDINANCE NO. 127, AN ORDINANCE TO ESTABLISH FINISH GRADES FOR A PORTION OF OAK STREET WAS READ THE SECOND TIME FULLY AND DISTINCTLY AT LENGTH. A MOTION WAS MADE BY COUNCILMAN HANKS AND SECONDED BY COUNCILMAN GOETZ THAT ORDINANCE No. 127 BE ADOPTED. MOTION CARRIED UNANIMOUSLY.

AN ORDINANCE IN REGARD TO THE FIRE DEPARTMENT WAS READ. THE MAYOR APPOINTED COUNCILMAN GOETZ AND COUNCILMAN HANKS TO STUDY THE ORDINANCE WITH THE FIRE CHIEF AND MAKE THE NECESSARY CHANGES BEFORE THE NEXT REGULAR COUNCIL MEETING.
