

MINUTES OF REGULAR MEETING
OF THE CITY COUNCIL
HELD IN BROOKINGS, OREGON,
ON AUGUST 11, 1959

THE COUNCIL MET IN REGULAR SESSION ON AUGUST 11, 1959, AT 8:00 O'CLOCK P.M.

PRESENT WERE MAYOR CAMPBELL, COUNCILMEN HEIN, GOETZ, PHETTEPLACE, HANKS, ROBERT KERR, BILL SPENCER, RECORDER HUDDLESTON, EVERETT ECHOLS, CHIEF CROSS, JUDGE KIRBY AND OTHERS.

MINUTES OF THE REGULAR MEETING HELD ON JULY 14, 1959, AND THE SPECIAL MEETINGS HELD ON JULY 17, 1959, JULY 23, 1959, AND JULY 24, 1959, WERE READ AND APPROVED.

A LETTER FROM R. F. POSTON OF THE DEPARTMENT OF HEALTH, EDUCATION AND WELFARE IN REGARD TO THE CITY'S DELAY IN SUBMISSION OF PART B OF THE OFFER AND ACCEPTANCE WAS READ.

MRS. MYERS INQUIRED WHEN THE SEWER WOULD GO IN ON PACIFIC AVENUE SO THEY COULD CONNECT TO THE SEWER AS THE SEPTIC TANK HAD CAVED IN. THE COUNCIL INSTRUCTED HER TO HAVE A TEMPORARY DRAIN FIELD MADE AND THAT THE SEWER WOULD BE INSTALLED WITHIN THE NEXT FEW MONTHS.

BUD CROSS REPORTED THAT TWO TRAILERS HAD MOVED TO TOWN AND ARE NOW PARKED ON RANSOM AND HASSETT STREETS. THE COUNCIL GAVE HIM AUTHORITY TO ORDER THE OWNERS TO MOVE THEM OUTSIDE THE CITY.

STORAGE OF EXPLOSIVES INSIDE THE CITY LIMITS WAS DISCUSSED. ATTORNEY BALDERREE WAS INSTRUCTED TO PREPARE AN ORDINANCE TO GOVERN STORAGE OF EXPLOSIVE MATERIALS.

MR. BANKUS WAS PRESENT ^{with} TO REQUEST THE COUNCIL TO FURNISH ASSISTANCE TO HIM IN LOCATING HIS WATER MAINS. AFTER CONSIDERABLE DISCUSSION THE MATTER WAS TABLED FOR FURTHER CONSIDERATION.

ORDINANCE NO. 128 CREATING STREET IMPROVEMENT DISTRICT No. 1 WAS READ THE FIRST TIME FULLY AND DISTINCTLY AT LENGTH. THEREUPON COUNCILMAN HEIN MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND THAT SAID ORDINANCE BE READ THE SECOND TIME BY TITLE ONLY. THIS MOTION WAS SECONDED BY COUNCILMAN GOETZ. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:
