

MINUTES OF REGULAR MEETING
OF THE CITY COUNCIL
HELD IN BROOKINGS, OREGON,
ON SEPTEMBER 8, 1959

THE COUNCIL MET IN REGULAR SESSION ON SEPTEMBER 8, 1959, AT 8:00 O'CLOCK P.M.

PRESENT WERE MAYOR CAMPBELL, COUNCILMEN HEIN, GOETZ, PHETTEPLACE, ATTORNEY BALDERREE, RECORDER HUDDLESTON AND JUDGE KIRBY.

THE MINUTES OF THE REGULAR MEETING HELD ON AUGUST 11, 1959, AND THE SPECIAL MEETINGS HELD ON AUGUST 19, 1959, AND SEPTEMBER 1, 1959, WERE READ AND APPROVED.

MR. DARROW WAS PRESENT TO REQUEST THAT THE CITY DEED HIM THE EIGHT FOOT UTILITY STRIP ADJOINING LOT 1, OF THE DIXON PLAT. THE COUNCIL INSTRUCTED HIM TO CONTACT THE TITLE GUARANTEE AND ABSTRACT COMPANY OR THE COUNTY ASSESSOR TO FIND THE STATUS OF THE STRIP AS IT DID NOT BELONG TO THE CITY.

ORDINANCE NO. 135, AN ORDINANCE APPROVING AND CONFIRMING THE EXECUTION OF A CERTAIN AGREEMENT DATED SEPTEMBER 1, 1959, WAIVING THE IMMUNITY OF THE CITY TO COURT PROCEEDINGS UNDER CERTAIN CONDITIONS, PROHIBITING THE TRESPASSING OVER CERTAIN PROPERTY, PROVIDING PENALTY FOR THE VIOLATION THEREOF AND DECLARING AN EMERGENCY WAS READ THE FIRST TIME FULLY AND DISTINCTLY AT LENGTH. THEREUPON COUNCILMAN GOETZ MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND THAT SAID ORDINANCE BE READ THE SECOND TIME BY TITLE ONLY. THIS MOTION WAS SECONDED BY COUNCILMAN HEIN. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

ORDINANCE NO. 136, AN ORDINANCE PROVIDING FOR THE RIGHT OF TRIAL BY JURY IN THE MUNICIPAL COURT OF THE CITY OF BROOKINGS, ESTABLISHING THE METHOD AND PROCEDURE FOR SELECTING A JURY PANEL AND TRIAL JURORS, PROVIDING FOR A JURY FEE AND DECLARING AN EMERGENCY WAS READ THE FIRST TIME FULLY AND DISTINCTLY AT LENGTH. THEREUPON COUNCILMAN PHETTEPLACE MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND THAT SAID ORDINANCE BE READ THE SECOND TIME BY TITLE ONLY. THIS MOTION WAS SECONDED BY COUNCILMAN HEIN. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

ORDINANCE NO. 137, AN ORDINANCE AMENDING ORDINANCE No. 116 OF THE CITY OF BROOKINGS BY PROVIDING FEES AND CHARGES TO BE PAID BY AN OWNER DESIRING TO CONNECT HIS PROPERTY WITH A SANITARY SEWER, WHICH PROPERTY HAS NOT BEEN ASSESSED FOR THE CONSTRUCTION OF A SEWER, PROVIDING A PENALTY FOR THE VIOLATION HEREOF, AND DECLARING AN EMERGENCY WAS READ THE FIRST TIME FULLY AND DISTINCTLY AT LENGTH.

THEREUPON COUNCILMAN HEIN MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND THAT SAID ORDINANCE BE READ THE SECOND TIME BY TITLE ONLY. ORDINANCE NO. 142, AN ORDINANCE TO AMEND SECTIONS 22 AND 24 OF ORDINANCE No. 58, APPROVED JUNE 9, 1954, PROVIDING FOR INITIATIVE AND REFERENDUM PROCEDURE AND DECLARING AN EMERGENCY WAS READ THE FIRST TIME FULLY AND DISTINCTLY AT LENGTH. THEREUPON COUNCILMAN PHETTEPLACE MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND THAT SAID ORDINANCE BE READ THE SECOND TIME BY TITLE ONLY. THIS MOTION WAS SECONDED BY COUNCILMAN HEIN. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

"AYES": MAYOR CAMPBELL AND COUNCILMEN HEIN, PHETTEPLACE AND GOETZ.

"NAYS": NONE

"ABSENT": COUNCILMAN HANKS.

THE MAYOR THEN DECLARED THAT SAID MOTION HAD DULY CARRIED AND DIRECTED THAT ORDINANCE No. 141 BE READ THE SECOND TIME BY TITLE ONLY. SAID ORDINANCE WAS THEREUPON READ THE SECOND TIME BY TITLE ONLY.

THEREUPON COUNCILMAN GOETZ MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND SAID ORDINANCE BE NOW PASSED TO ITS THIRD READING BY TITLE ONLY, AND PLACE UPON ITS FINAL PASSAGE AND BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE. SAID MOTION WAS SECONDED BY COUNCILMAN HEIN. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

"AYES": MAYOR CAMPBELL AND COUNCILMEN HEIN, PHETTEPLACE AND GOETZ.

"NAYS": NONE

"ABSENT": COUNCILMAN HANKS.

THE MAYOR THEREUPON STATED THE MOTION HAD DULY CARRIED AND DIRECTED THAT ORDINANCE No. 142 BE READ THE THIRD TIME BY TITLE ONLY. SAID ORDINANCE WAS THEN READ THE THIRD TIME BY TITLE ONLY. THEREUPON COUNCILMAN PHETTEPLACE MOVED THAT THE RULES BE SUSPENDED AND AN EMERGENCY DECLARED AND THAT SAID ORDINANCE BE ADOPTED. THIS MOTION WAS SECONDED BY COUNCILMAN GOETZ. THE MAYOR THEREUPON STATED THE MOTION AND THE VOTE RESULTED AS FOLLOWS:

"AYES": MAYOR CAMPBELL AND COUNCILMEN HEIN, PHETTEPLACE AND GOETZ.

"NAYS": NONE

"ABSENT": COUNCILMAN HANKS.

SAID ORDINANCE No. 142 HAVING RECEIVED THE REQUIRED NUMBER OF VOTES, THE MAYOR DECLARED THE SAME TO HAVE DULY PASSED AND TO HAVE BEEN DULY ADOPTED.

A MOTION WAS MADE BY COUNCILMAN GOETZ AND SECONDED BY COUNCILMAN PHETTEPLACE THAT THE MAYOR BE AUTHORIZED TO ORDER A NEW COUNCIL TABLE. MOTION CARRIED.

A MOTION WAS MADE BY COUNCILMAN GOETZ AND SECONDED BY COUNCILMAN PHETTEPLACE THAT THE MAYOR AND CITY RECORDER BE AUTHORIZED TO ACCEPT LOWEST EFFECTIVE BID FOR THE CONSTRUCTION OF THE PUMP STATION AND THAT THE CONSTRUCTION/COMPLETION DATE BE EXTENDED SEPTEMBER 1960. MOTION CARRIED UNANIMOUSLY.
