

ORDINANCE NO. 90-O-466

AN ORDINANCE AMENDING THE COMPREHENSIVE PLAN MAP AND ZONING MAP OF THE CITY OF BROOKINGS BY THE REDESIGNATION AND REZONING FROM INDUSTRIAL AND COMMERCIAL TO COMMERCIAL, RESIDENTIAL AND INDUSTRIAL AND REZONING FROM COMMERCIAL, INDUSTRIAL AND RESIDENTIAL TO COMMERCIAL, RESIDENTIAL AND INDUSTRIAL UPON THAT CERTAIN REAL PROPERTY, BELOW DESCRIBED. (South Coast Lumber Co.)

WHEREAS, a public hearing was held on July 3, 1990 before the Brookings Planning Commission for the purpose of considering a request for a comprehensive plan map amendment from Industrial and Commercial to Commercial on 21.7 acres, Residential on 18.2 acres and Industrial on 13.7 acres, of property located on the south side of Highway 101 between Mill Beach Road on the west and the southerly extension of Center Street on the east and south (identified as Assessor's Map No. 41-13-6D, Tax Lot Nos. 200, 301, 302, 306, and 307.

WHEREAS, following closure of the public hearing after considerable evidence and testimony was presented by proponents and opponents, the Planning Commission, by a unanimous vote, directed the Planning Director to prepare a recommendation, with findings, to the City Council, for approval of the request for the redesignation from Industrial and Commercial to Commercial, Residential and Industrial and rezoning from C-3, M-2 and R-2 to C-3 on 21.7 acres, R-3 on 18.2 acres and M-2 on 13.7 acres; and

WHEREAS, the Brookings City Council, at its regularly scheduled meeting of August 13, 1990, did conduct a public hearing on this matter, during which hearing considerable testimony and evidence was presented by the applicant's representative, interested parties and recommendations were received from and presented by the Planning Director; and

WHEREAS, at the conclusion of said public hearing, after consideration and discussion, the Brookings City Council, upon a motion duly seconded, did vote in the majority to adopt a Final Order and Findings of Fact document to be presented at the September 10, 1990 meeting on its decision to grant the applicant's request;

The city of Brookings ordains as follows:

Section 1. Amendment to Comprehensive Plan Map and Zoning Map to designate property as C-3. The Comprehensive Plan Map and Zoning Map of the City of Brookings are amended to show that the following described property is designated Commercial and is zoned Central Commercial (C-3):

Section 2. Amendment to Comprehensive Plan Map and Zoning Map to designate property as R-3. The Comprehensive Plan Map and Zoning Map of the City of Brookings are amended to show that the following described property is designated Residential and is zoned Multi-Family Residential (R-3):

Section 3. Amendment to Comprehensive Plan Map and Zoning

Section 3. Amendment to Comprehensive Plan Map and Zoning Map to designate property as M-2. The Comprehensive Plan Map and Zoning Map of the City of Brookings are amended to show that the following described property is designated Industrial and is zoned General Industrial (M-2):
