

ORDINANCE NO. 365

AN ORDINANCE WITHDRAWING FROM THE DAWSON TRACT RURAL FIRE PROTECTION DISTRICT CERTAIN TERRITORY THAT HAS BEEN ANNEXED TO THE CITY OF BROOKINGS; AND ASSUMING CERTAIN OBLIGATIONS OF THE WITHDRAWN TERRITORY.

WHEREAS, certain territory described below was annexed to the City of Brookings by Ordinance No. 362; and

WHEREAS, the territory described below is located within the boundaries of the Dawson Tract Rural Fire Protection District; and

WHEREAS, pursuant to Resolution No. 316 the Common Council of the City of Brookings held a public hearing to hear any objections to the withdrawal of the property from the above public service district;

NOW, THEREFORE,

The City of Brookings does ordain as follows:

Section 1. Withdrawal. The following territory within the boundaries of the Dawson Tract Rural Fire Protection District shall be withdrawn from the district upon the effective date of this ordinance, to-wit:

A strip of land for right of way purposes, 40 feet in width as described in BR 31, page 379, Curry County Records, located in the Northeast Quarter (NE $\frac{1}{4}$) of Section 36, Township 40 South, Range 14 West, Willamette Meridian, Curry County, Oregon, more particularly described as follows:

Commencing at the Quarter Section Corner on the East side of Section 36, thence North 390.0 feet, thence West 163.0 feet, thence North 400.0 feet to the True Point of Beginning.

Thence S 31°00' W 119.2 feet;

Thence S 10°49' W 175.3 feet;

Thence S 57°30' W 132.5 feet;

Thence N 83°43' W 174.1 feet;

Thence S 51°17' W 138.4 feet;

Thence N 76°33' W 69.1 feet;

Thence N 65°42' W 117.25 feet;

Thence N 62°02' W 541.1 feet;

Thence N 75°29' W 310.7 feet;

Thence S 85°06' W 164.2 feet;

Thence S 60°48' W 202.5 feet;

Thence S 51°49' W 72.9 feet more or less to the Northeasterly boundary of the relocated Oregon Coast Highway;

Thence along said highway boundary S 28°54' E 40.52 feet;
 Thence N 51°49' E 76.30 feet;
 Thence N 60°48' E 191.14 feet;
 Thence N 85°06' E 148.75 feet;
 Thence S 75°29' E 299.13 feet;
 Thence S 62°02' E 537.65 feet;
 Thence S 65°42' E 122.34 feet;
 Thence S 76°33' E 92.48 feet;
 Thence N 51°17' E 141.40 feet;
 Thence S 83°43' E 171.61 feet;
 Thence N 57°30' E 163.85 feet;
 Thence N 10°49' E 185.35 feet;
 Thence N 31°00' E 45.49 feet;
 Thence N 77.68' feet to the true point of beginning.

Section 2. Assumption of Obligations. The city elects to assume the obligation of the withdrawn territory and be liable to the district therefor for the amount of taxation which otherwise would be assessed each year against the property in the part withdrawn to, but not extending beyond, the effective date of this Ordinance.
